Dist No. 4, P.S.-Siliguri, and started abusing her in

pregnancy and she was admitted to Siliguri,
Distt. Hospital and discharged on dt. 09.07.24.

Sir, the above noted alleged persons are very
despotic & dangerous in nature and they have
threatened us for dire consequences.

So, please take necessary action against the
above noted alleged persons
