In producing herewith five (05) accused persons namely (i) Manjit Oraon (26 yrs) S/O Late Ganesh Oraon of Sishabari, Uttar Palash, PO- Champasari, PS- Pradhan Nagar, Dist.-Darjeeling (ii) Sanjoy Bhagat (34 yrs) S/O Ram Dhani Bhagat of Debidanga, Kalimandir Road, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling (iii) Indrajit Gosai (27 yrs) S/O Dilip Gosai of Debidanga, Qtr line, PO- Champasari, PS- Pradhan Ngar, Dit.- Darjeleing (iv) Bijay Roy (28 yrs) S/O Lt Anil Roy of Debidanga, Middle Palash Road, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeling and (v) Subhash Singh (27 yrs) S/O Lt Anil Singh of Kalkut, Debidanga, PO- Chamasari, PS- Pradhan Nagar, Dist.- Darjeeling and the following articles under seizure viz :- (i) one multi colour nylan bag (ii) one iron made hammer with its wooden handle (iii) one iron made sharp cutting weapon locally called as "Hasua" including its wooden butt measuring approx 18" in length. (iv) one iron made weapon locally called as "Hasua" measuring (approx) 18 inches in length including its wooden butt. (v) one iron made sharp cutting weapon locally called as "Bhojali cum Khukri" measuring 16 inches in length (approx) including its wooden butt. (vi) one iron made red colour instruments locally called as "Hasblade" measuring approx 20 inches in length wooden butt (vii) one scrue driver measuring plastic butt (viii) one iron made approx 15 inches in length including its red colour instruments locally called as "Plus", I, ASI Biplab Kr Das of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted five (05) arrested accused persons and their 03/04 unknown associates involved in this crime to the effect that on 11.07.24 at 01.55 hrs received a specific source information that about 08/09 persons assembled in the varanda of Champasari Junior Basic School near Debidanga Bazar under PS- Pradhan Nagar, Dist.- Darjeeling equipped with deadly weapons and were taking preparation for committing dacoity at Debidanga and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No 564 dated 11.07.24. As per your kind order and direction, at about 02.05 hrs, I, accompanied with SI Goutam Mallik, SI Bandhan Roy, C/1169 Prasenjit Barman, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS and the Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling left for Debidanga Bazar under Pradhan Nagar PS, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 566 dated 11.07.2024. On way, I briefed all the Police personnel sharing the information in hand and also informed RT van officer ASI Sanjib Mukharjee of Pradhan Nagar PS and directed him to come near Debidanga bazar to assist us. At around 00.25 hrs we arrived at Debidanga Bazar and contact with my source while he stated that the miscreants assembled in the veranda of Champasari Junior Basic School. Then, I contacted with independent witnesses but due to heavy rain only one witness namely Sona Barai @ Sonai S/O Siklal Barai of Barai of Debidanga Bazar, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling came to me. I informed him regarding the information and requested him to remain present and act as witness if any search and seizure would have to be made, upon which he agreed.

Thereafter, I contacted with my source and as pointed by the source we noticed that 08/09 persons assembled in the veranda of Champasari Junior Basic School and they were whispering in a very low voice. We cordoned the place with due care and caution. On seeing police personnel, they tried to flee away from the spot but on hot chase we managed to apprehend above noted five (05) accused persons while 03/04 others managed to flee away from the back side door taking the opportunity of darkness. Thereafter, we disclosed our identities as Police personnel (as we all were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered one multi colour nylan bag containing the above noted weapons of offence from Sl No (ii) to (viii) were kept concealed from their joint possession. On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such late hour of night. Finally they confessed that they along with their associates assembled there and were making preparation for committing dacoity at Debidanga and its surrounding areas.

Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 02.15 hrs to 03.40 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest observing all the formalities of arrest. They are informed over their ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.- Darjeeling as per BNSS. I, accordingly brought all the five (05) arrested accused persons along with seized articles at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons, that they along with their associates assembled there and making preparation for committing dacoity at Debidanga and its surrounding areas.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Debidanga and its surrounding areas.

Hence, I therefore pray before you that a specific case under proper sections of Law may kindly be started against following five (05) arrested accused persons namely (i) Manjit Oraon (26 yrs) S/O Late Ganesh Oraon of Sishabari, Uttar Palash, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Sanjoy Bhagat (34 yrs) S/O Ram Dhani Bhagat of Debidanga, Kalimandir Road, PO- Champasari, PS- Pradhan Nagar, Dist.- Darjeeling (iii) Indrajit Gosai (27 yrs) S/O Dilip Gosai of Debidanga, Qtr line, PO- Champasari, PS- Pradhan Ngar, Dit.-Darjeleing (iv) Bijay Roy (28 yrs) S/O Lt Anil Roy of Debidanga, Middle Palash Road, PO-Champasari, PS- Pradhan Nagar, Dist.- Darjeling and (v) Subhash Singh (27 yrs) S/O Lt Anil Singh of Kalkut, Debidanga, PO- Chamasari, PS- Pradhan Nagar, Dist.- Darjeeling (and others 03/04 unknown miscreants and arrange for its investigation.
