Sir,

I, Smt. Sarbani Dhar Sharma, daughter of Late Bibhuti Rajan Dharsharma, and wife of Sri. Debabrato Ganguli, Teacher by profession, residing at Champasari More, Near Sunrise Foundation and Dutta Dental, S.M.C. Ward No. 46, P.O. & P.S. Pradhan Nagar, District Darjeeling – 7347003, would like to bring to your notice the following incident that on 09/07/2024, at approximately 02:45 PM, while I was returning from the school (Techno India Group Public School) where I teach in my car (Maruti Alto 800 VXL, registration number WB 74AK0991), there was a usual traffic jam at Dagapur, Near Darjeeling More, Siliguri. Suddenly, a Tata Sumo (four-wheeler) bearing registration number WB 26R 5082, driven by Mr. Arijit Nandi, collided/hit from the back and my Maruti Alto 800 VXL car got seriously damaged. Due to the said collision my said car was damaged and I also suffered injuries to my head and hip.

At the place of occurrence said Arijit Nandi assured me that he would compensate for the damage caused by him. Due to the ongoing exam period for my students and the crowded location, I had to leave trusting his word. On 10/07/2024 when I took my car to Sevoke Motors showroom for repair and replacement of the damaged parts of my vehicle and called said Arijit Nandi to come at the showroom, thereon mechanics estimated the repairing cost to be Rs. 6,000/- [Rupees (six thousand) only]. However, during our conversation at the showroom, said Arijit Nandi alongwith two persons refused to pay the full repair cost and insisted on repairing my vehicle at a place known to him. When I confronted on having the repairing done at the showroom, he agreed to pay only Rs. 2,000/- [Rupees (two thousand) only] and advised me to claim the rest from my insurance company. This contradicts his initial promise to cover the entire damage. And while leaving they further stated that they have good connection with the police personnels so you can't do anything against us and openly challenged me that go seek for the legal remedies they are not worried and care about that. Further, I discovered that the Tata Sumo being No. WB 26R5082, registered as a private vehicle, is being used for commercial purposes. This matter requires thorough investigation.

Since I was busy for taking classes at school and for correction of examination papers so there was delay in lodging this complaint. I am currently suffering from acute mental distress and anxiety due to this incident. I sincerely request you to investigate the matter and take appropriate action against said Arijit Nandi (mobile number: +91 9832410003) and Avijit Nanadi (mobile number +91 7679171896). I am willing to provide any further information required for the investigation. Thank you for your prompt attention to this matter.
