I, Smt Anu Chettri ( Adhaar No 693120991023) w/o Sri Suraj Kumar Mahawar , d/o Ganga Bahadur Chettri , currently residing in a rented flat at Casablanca apartments , Halermatha — Chaitannyapur Road . near Sishu Tola School , P.O. New rangia , P.S> Matigara , Dist. Darjeeling — 734013 , West Bengal , would like to draw your kind attention to the following matter .

My married was solemnized at Maa Kali Mandir on 02-07-2021 at Bhujiapani, Bagdogra Dist. Darjeeling with Sri Suraj Kumar Mahawar, s/o Sri Ashok Kumar Mahawar (TGT Teacher of math at Kendriya Vidalaya Sangsthan – Bengdubi), out of love as per Hindu Customs. After our marriage we lived peacefully at a rented house at Air Port More, Baagdogra, until-October 2023.

However, after some time, my husband started torturing me physically and mentally, which resulted in several injuries. For the sake of social prestige, I did not inform the police or relatives, In December, 2023, we shifted to CASABLANCA APARTENTS. On 19-02-2024 we went Siliguri court for marriage registration but it was postponed by Advocate Manishankar (M – 8824490400)

On 13-05-2024, my husband's father, Sri Ashok kumar Mahawar (M-8055836224) and his uncle (M-9413482550) came to Slliguri and threatened me to divorce my husband offering me 5 lakhs. When I refused, they attempted to kill me through my husband in a bikee accident. They continued to pressure me, but I remained sreadfast.

On the same day, my husband instead on taking me to Siliguri. When I tried to sit on his bike, he drove dangerously with thee intent me. People intervened near Sabitri – more, Shuvmandir and my husband slapped me publicly, but bystanders saved me.:

After goinf home, he and his family began demanding a heavy dowry from me, If I did not agree, they said they would not accept me as their daughter in law, When I refused they decided to pursue a divorce. They came to Siliguri court on 04.06.2024 but fled seeing me, there. They then informed me that they would come to court again and on 10.07.2024 Mr. Suraj Kumar Mahawar, his father Ashoke Kumar and his uncle Mukesh came to Siliguri court for the settlement. As per discussion with them they will pay Rs. 10,00,000.00 to me on the spot with Agreement. They then had taken my signature in Agreement papers as they given Rs. 10,00,000.00. After taken my signature they told me that I already signed in paper as documents and not to pay anything to me. Then they quarrelled with me, slapped me

& push me . In this way they tortured me by physically and mentally and then fled from the spot without given the amount .

My husband has now blocked me everywhere and refuses to contact me. I call his family member, they demand huge amount of dowry which is impossible for me to manage such a huge amount. They have stated that they will not accept me as their daughter in law without the dowry and have denied any settlement with me. I am now experiencing severe mental distress due to continuous torture from my husband and his family members. I am ilving in extreme anxiety.

Therefore I respectfully, request you to look into the matter and lodge FIR against them to take necessary actions, and save my life from further harm.
