Respected Sir,

I, Jyoti Kaur Seal, wife of Bhaskar Seal, daughter of Gordayal Singh, resident of 'Mihijam' Building, Top Floor, Rishi Aurobindo Road, Hakimpara, Siliguri Municipal Corporation, P.O. & P.S. Siliguri, District – Darjeeling, West Bengal - 734001 would like to inform you that that in the month of June, 2014 my marriage was solemnized with my husband in the presence of our family members and relatives as per Hindu rites and customs at Sevokeshwari Kali Mandir, NH 31A, Siliguri, District – Darjeeling, Weast Bengal.

At the time of the marriage as per the demand of my husband and in laws, my father and relatives gave many valuable articles including furniture, gold ornaments, jewelry and cash worth amounting Rs. 2,00,000/- (Rupees Two Lakhs only) and thereafter my husband brought me to my matrimonial home at Rishi Aurobindo Road, Hakimpara, Siliguri Municipal Corporation, P.O. & P.S. Siliguri, District – Darjeeling, West Bengal – 734001 i.e., at the above-mentioned address of my husband and as per his direction I handed over my above-mentioned stridhan articles alongwith cash amount to my husband and in laws and which is presently under their custody.

After passing of one month of the said marriage, I found changes in the attitude and behaviour of my husband as he started to come late night at home in a drunken condition and abused me in most



filthy terms by throwing slangs upon me and making abusive remarks over my family members

On every occasion, when I requested him not to come home drunk and make such remarks over me or my family members, my husband used to physically assault me by confining me behind locked doors till late night but I swallowed everything with a hope that one day everything will be alright.

On 20.10.2015, I gave birth to a male child, Debaroon Seal but even after the birth of the child there was no change in the behaviour of my husband as he always neglected to provide basic amenities like bread and milk for our minor child and on many occasions my husband brutally assaulted me in front of my child.

I would like to further inform you that my brother-in-law Sri Sourav Seal also make abusive remarks over me by calling me unchaste and lady of immoral character and my husband manhandled me several times alongwith by brother-in-law with his support and on many occasions I alongwith my child were beaten and kept behind locked doors without food after such assault.

I decided to break my silence when yesterday at about 1:30 p.m. my husband again came to home in drunken condition and pulled my hairs by pushing me down to the ground and brutally assaulted me with kicks and blows abusing most filthy languages upon me and then he tightly hold and pressed my throat with his hand by pushing me towards the wall for which I could not breathe and somehow I managed to escape from his clutches and my treatment took place at Siliguri District Hospital.

As per the advice of the doctor for taking bed rest and due to the heavy bodily pain, I was not in a position to move myself and today

morning at about 7:30 a.m. while I was taking rest at my bed, my husband suddenly came over me with a pillow in his hand and pressed the pillow over my mouth with his full strength and force and due to suffocation I was almost out of my breathe but somehow I managed to save my life and run from there.

I am a helpless lady who and victimised by my husband and brother-in-law Sourav Seal and the life of mine alongwith my child is in extreme risk and danger and which has adversely affected our health condition.

It is my humble and sincere request to you to look into this matter at the earliest in order to save life and liberty of mine and my minor child from my husband and brother-in-law and take immediate and necessary actions against them and charge them under relevant laws of the land.
