In producing herewith following two tractors having Registration no WB74 BR 7311 and WB 74 BR 7320 loaded with river bed materials under proper seizure.

I, ASI Mukul Bosu S/O Bimal Bosu of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the driver and owner of two tractors bearing no WB74 BR 7311 and WB 74 BR 7320 loaded with river bed materials to the effect that on 12.07.2024 at 13.25 hrs while performing CS II mobile van vide BKN PS GDE no 559/24 dated -12.07.2024, I along with C/ 828 Dulal Ch Barman, C/-1191 Jatindra nath Singh had been to Betgaera under Bhaktinagar PS area and found the above noted tractors loaded with river bed materials coming from Dem-Dema river ghat. When I tried to stop the above noted tractors, the drivers of the said tractors fled away from the spot. Accordingly I tried to apprehend the driver but in vain. I searched the every possible place and also wait for the claimant of the said tractors but nobody turned up as claimant of the said tractors. Finding no other alternative as such I seized the above noted tractors loaded with river bed materials under proper seizure list. The whole process of seizure was made in between 14.40hrs to 15.25hrs under proper audio video record as per the norms.

During local enquiry it revealed that driver and owners of those seized tractors and others are involved in illegal mining and transporting of river bed materials without valid permission and doing the business clandestinely.

Hence, I pray before your good office that a specific case may kindly be started against the driver and owner of above noted tractors having Registration no WB74 BR 7311 and WB 74 BR 7320 loaded with river bed materials and others under proper section of Law and arrange for its investigation.
