In producing herewith five (5) accused persons namely 1. Manik Sarkar (28] S/o Lt. Ranjit Sarkar of Madani Bazar PS NJP Dist. Jalpaiguri 2. Babu Roy (35) S/o Lt. Hirambo Roy of Madani Bazar PS NJP Dist. Jalpaiguri 3. Prasenjit Barman (30) S/o Jatin Barman of Madani Bazar PS NJP Dist. Jalpaiguri 4. Atarul Hoque (40) S/o Lt. Samsul Hoque of Madani Bazar PS NJP Dist. Jalpaiguri 5. Samir Bhakta (27) S/o Manik Bhakta of Ghora More Mamata Para PS NJP Dist. Jalpaiguri along with seized articles viz

1. One iron made "Hasua" one side sharp having length approx 23 inches including plastic butt from the possession of Manik Sarkar.
2. One iron made "Daa" with one side sharp having length approx 14.5 inchesh including plastic butt from the possession of accused person Babu Roy.
3. One iron made weapon called as " Khuria" one side carved measuring approx 20.5 " inches from the possession of accused Prasenjit Barman.
4. One iron made weapon called as " Batali" length approx 10 inches including plastic Butt from the possession of accused person Atarul Hoque .
5. One iron made "Sabal" one side sharp length approx 25 inches from the possession of accused person Samir Bhakta.
6. Two Electronic torch light from the PO.
7. Two Flake Cigerate open packets in containing 15 pcs Cigerate from the PO.


I SI Tanmay Kundu of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 6/7 persons to the effect that on the night 14.07-24 at 00-05 hrs received secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at abandoned Railway building at South Colony under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 964 dt. 14.07.24 . As per your kind direction at 00-15 hrs myself alongwith, ASI Nilam Swarnakar, ASI Sudarshan Mandal, C/1462 Sajjan Tamang, VP-13 Jamirul Islam CV-297 Putul Roy, CV-306 Biswajit Roy, CV-824 Niru Kumar Yadav left from PS vide NJP PS GDE No. 965 dt. 14.07.24 with night mobile van officer SI Kaji Rejaul Karim , HG-1600 Sujay Dey , CV-300 Madhab Roy for South Colony to verify the veracity of the information and to work upon it . We reached near the spot as confirmed by the source at about 00-35 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the abandoned Railway building, found a group of 11/12 persons assemble and gossiping in a dark place at that place. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the 05 (five) persons noted above and the others 6/7 persons managed to flee away from the spot. On interrogation they disclosed their identity which was not verified and they also stated that they alongwith their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Tinbatti More under NJP PS. Thereafter all the apprehended persons were searched and due to late night could not find any independent witness to present at the time of

search and seizure.. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in videography as per provision of law . Accordingly I arrested the above noted accused persons u/s 35 BNSS. The seizure was made between 00-50 hrs to 01-35 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against 1. Manik Sarkar (28) S/o Lt. Ranjit Sarkar of Madani Bazar PS NJP Dist. Jalpaiguri 2. Babu Roy (35) S/o Lt. Hirambo Roy of Madani Bazar PS NJP Dist. Jalpaiguri 3. Prasenjit Barman (30) S/o Jatin Barman of Madani Bazar PS NJP Dist. Jalpaiguri 4. Atarul Hoque (40) S/o Lt. Samsul Hoque of Madani Bazar PS NJP Dist. Jalpaiguri 5. Samir Bhakta (27) S/o Manik Bhakta of Ghora More Mamata Para PS NJP Dist. Jalpaiguri and other 6/7 persons and arranged for its investigation.
