Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Sanjib Oraon (20 yrs approx), S/O- Lt. Ratilal Oraon of Nehalu Jote, PO- Nema, PS- Matigara, Dst- Darjeeling and 10 (ten) bottles of "Carlsberg Elephant Premium" beer each bottle containing 650 ml and in total 6.5 Liter as seized articles. The ground of arrest duly been communicated with him.

I, SI Shib Sankar Das, of Matigara PS, SPC under your kind control beg to state that on 14.07.2024 during my special mobile van duty vide MTG PS GDE No. 1324, at about 19.15 hrs, I received a secret source information that one person as noted above is selling liquor illegally from his house located at Nehalujote, PO- Nema, PS- Matigara, Dist.- Darjeeling. Accordingly, myself along with PSI Avijit Banik, ASI Dharendra Nath Mandal, C/868 Sujal Roy all are of Matigara PS, SPC left for Nehalujote, PO- Nema under Matigara PS to work out the information in hand. At 19.40 hrs we arrived at Nehalujote in the house of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling liquor from his house. On being asked he disclosed his name and address as noted above. During raid, the persons who were buying liquor were able to flee away from the house of the accused person. During interrogation he disclosed that he is selling liquor from his house located at Nehalujote, PO- Nema, PS- Matigara, Dist- Darjeeling for his illegal gain. On being search his house, the above noted liquor were recovered. On demand he failed to produce any documents/license in respect of store/sale of the liquor which were recovered from his house. Accordingly, I seized the above noted liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of search, seizure and arrest. The whole process of search, seizure, label & arrest was made in between 19:40 hrs to 20.40 hrs on 14.07.2024 under videography.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Sanjib Oraon (20 yrs approx), S/O- Lt. Ratilal Oraon of Nehalu Jote, PO- Nema, PS- Matigara, Dst- Darjeeling and arrange for its investigation.
