In producing herewith one arrested accused person namely (i) Babu Das (28yrs) S/o- Lt. Manik Das of Shorbohara Colony ,W/no.28 PS- Siliguri, Dist- Darjeeling arrested u/s- 35(1) BNSS along with following seized articles (i) 11 (Eleven) Sealed pet Bottles Himalayan Gold 60 Up Country Spirit each bottle containing 600 ML labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal each (Amounting of Rs. 120x11=Rs-1320/-) in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest

I, PSI Koushik Raha S/O- Jitendra Raha of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person namely Babu Das (28yrs) S/o- Lt. Manik Das of Shorbohara Colony, W/no.28 PS- Siliguri, Dist- Darjeeling to the effect that on 14.07.24 at 14.40 hrs acting on secret source information that the above W/no./28 under Siliguri PS in order to clandestinely dispose the same. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with ASI Subir Sen, ASI Debasish Das, C/160 Soumen Sarkar left for Shorbohara Colony under Siliguri PS vide GDE no- 289 dated 14.07.24. On reaching at 15:05 hrs there and as identified by the source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we manage to apprehend the above noted person and on interrogation he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up country Spirit to locality without any valid documents as he violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search recovered Eleven (11) Sealed Bottles Himalayan Gold 60 Up Country Spirit each containing 600 ML each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal (Amounting of Rs. 120 x11=Rs1320/-), in which one sealed bottle has taken from mother packet box as sample as per seizure list which was kept concealed in his shop situated at Sorbohara Colony under Siliguri PS. On being interrogation he could not produce any valid documents in respect of said liquor. He also stated that he is doing this Liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by them and the process of search and seizure also audio videographed. The seizure and label was made in between 15.10 hrs to 15:45 hrs. As such I arrested him U/S- 35 (1) BNSS after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely, (i) Babu Das (28yrs) S/o- Lt. Manik Das of Shorbohara Colony ,W/no.28 PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigation.
