Then and there the patient party demanded for the patient's death certificate from our hospital but as the patient was neither admitted or treated after Hemodialysis on 09.07.2024 nor expired at our hospital, we clearly refused to give them any death certificate. After listening this the patient party got violent and started shouting and also gave filthy languages to our doctors and staffs. They also damaged our hospital property by breaking glass of our Pharmacy and tried to damage more. They threatened our doctors and staffs stating that they are lawyers and will take down the hospital.

It is very surprising to find out that since 11/07/2024 (after 04:16 pm), Sujit Karak has not visited our hospital and very cleverly fled away since then. We tried to contact him but we have failed.

Sir, very surprisingly that the patient party along with some advocates have made several false allegations against us and made chaos and used filthy languages for our doctors, staffs and threatened all the doctors and staffs to face consequences.

I, therefore request you to kindly take necessary steps against the persons involved in this illegal activity and thereby save our reputation.
