**SUB: CONTINUOUS PHYSICAL & MENTAL CRUELTY & TORTURE
CAUSED UPON ME BY MY HUSBAND.**

Respected Sir

I, Smt. Supriya Mukherjee, wife of Sri. Arun Mukherjee, presently residing at C/O Neeta Kumari Singh, Vill- Chandborjote, P.O. Kadamtala, P.S. Matigara, District Darjeeling, pin-734011, West Bengal, would like to state you that I am married to one Arun Mukherjee, son of Tapan Mukherjee, resident of Kalamjote, P.O. Sushrutata Nagar, P.S. - Matigara, Dist. - Darjeeling, on 19/02/2009, at my parental house situated at Bandargachh, P.O. & P.S. Phansidewa, Dist- Darjeeling and the said marriage was an arrange marriage. That after my aforesaid marriage I started cohabiting with my husband at my matrimonial house at Kalamjote, P.O. Sushrutata Nagar, P.S. - Matigara, Dist. - Darjeeling. That my matrimonial house comprises of my father-in-law Tapan Mukherjee, mother-in-law, Kalpana Mukherjee, my husband, elder brother-in-law Tarun Mukherjee and his wife Shukla Mukherjee, while my elder brother-in-law and his wife mostly resides at his work place/quarter for his service purposes. That at the time of my aforesaid marriage, my parents had given Rs. 50,000/- (Rupees Fifty Thousand) only, in cash, 50 gram of gold jewellery including 1 (one) chain, 4 (four) bangles, 2 (two) rings, furnitures (Wooden Box Bed, Alna, Wooden Dressing Table, Almirah, fixtures, articles, electronics, utensils, apparels (banarashi wedding set, cotton saree 10 piece), Blanket 2 piece, mattress 1 piece, pillow 3 piece, bed sheet 3 piece and other satisfactory gifts to my husband like (1) one gold ring & 1 (one) gold chain and his family members. That out of the said wedlock, I gave birth to two children viz. Anusha Mukherjee on 20/12/2009 and Ayush Mukherjee on 15/09/15. That just within 3 (three) months of my marriage I was subjected to physical & mental cruelty & torture in my matrimonial house in hands of my husband and my in-laws for bringing more dowry from my parents and I have also very surprisingly found that my said husband is addicted to drinking alcohol and he used to beat me without any rhyme and reason or any issue and he also used to pick up quarrels on trifling issues with me and further abuse me with most filthy languages also in front of the neighbors almost everyday. That my husband is a govt. employee serving under B.S.F and as such that every time he visits home during his leave I was subjected to physical & mental cruelty & torture by my husband without any reason. It is also pertinent to mention here that my husband use to doubt on me and for such irrelevant doubt/suspicion he used to assault and abuse me without any rhyme and reason. That in the year of 2011 my in-laws had shifted to a new house within the same locality and as such that in that new house the

physical & mental cruelty & torture upon me by my husband had increased manifold and further I was ousted from my matrimonial house. That thereafter I had filed a complaint against my husband and as such that a Matigara Police Case No. 475/12, dated 13/8/12 was initiated against my husband. However many persons and well-wishers requested me to forgive my husband and as such that I was compelled to provide N.O.C for bail of my husband with respect of the aforesaid case. That thereafter my husband took me Rajasthan along with him and in the year of 2014, I gave birth to a female child but unfortunately within a month she succumbed to death. That thereafter my husband again started torture upon me blaming the death of new child. That due to such unbearable tortures by my husband I was compelled to complaint against my husband in his office and as such that action was taken against him. That thereafter I again became pregnant and in the year of 2015, I came back to my matrimonial house and gave birth to a male child (Ayush Mukherjee) on 15/09/15. It is pertinent to mention here that after birth of our son neither my husband nor my in-laws came to visit me or newly born child. It is also worth mentioning here that my husband at that period was on leave. That thereafter my husband started physical and mental torture upon me for giving birth to a male child and that he wanted a girl child. That out of everyday humiliation and tortures I was compelled to shift to a rented place in the year of 2018 but unfortunately my husband again tortured me and when other co-tenants came to rescue me, my husband created a huge dispute, violence and nuisance amongst other co-tenants and as such that the landlord made a police complaint and upon police intervention my husband had asked for forgiveness and promised for not repeating such violence and nuisance. That after such incident I again shifted to a new rented house of Rupa Thapa in the year of 2021. That on one occasion i.e Kali Puja Mela, in the month of July 2022, I visited my parental house along with my children and when my husband came to know about the same he called me and abused me with most filthy languages and further threatened me with dire consequences if I do not return home immediately. That thereafter in the month of August 2022 when my husband came back on leave he did not enter our house and further threatened me with dire consequences if I don't leave the house. It is pertinent to mention here that under such situation I was compelled to complaint before the B.H.M, 194 Battalion, BSF and informed him the dispute. That thereafter upon his intervention my husband came back home. That since my husband was in drunk condition he immediately slept on that night and on next morning when my husband woke up he abused and beat me and further ousted me. That thereafter I came back to my parental house. That I came to know from my neighbors that my husband had locked himself in the house and was continuously drinking alcohol. That my husband after a day or two called me and asked for forgiveness and further informed me that he is sick and needs medical attention and hearing such I thought to give one last chance to my husband and I came back from my parental house. That after elapse of few weeks my husband again started creating mental and physical tortures upon me and further threatened me that if I ever visited my parental house then I along with our

children's shall face dire consequences. He even abuse me with filthy languages if I could not answer his call and further restrained me to talk with my parents. That my husband always created violence and nuisance and out of shame and humiliation I was compelled to leave the house of Rupa Thapa and thereafter in the year 2023, I took rent in the house of Neeta Kumari Singh, situated at Chandborjote That I for the sake of our children's, have tolerated the physical and mental cruelty caused upon me by my husband but very recently i.e on 11/07/24 at around 10 P.M. my husband entered home heavily drunk and in that condition he intentionally tried to vomit over me. That considering his condition I did not utter a single word neither complain him for his such activities but my husband forced me to clean his vomit immediately. That I politely replied him that I shall clean his vomiting next day since I was already ill and after doing such stuffs I shall require to bath. That my husband thereafter became furious and started beating me brutally. That our kids started crying and requested my husband to stop beating but unfortunately he assaulted our kids to the extent that my husband attempted to choked the neck of our daughter. That hearing such huge chaos/dispute my land lady Neeta Kumari Singh immediately came to rescue/save us and as such that my husband even attempted to chock her neck. That only upon strong protest and intervention of our land lady our lives were saved. That thereafter my husband has ousted me along with my kids in midnight and finding no other alternatives I was compelled to take shelter in the store room of my land lady. That on the next day my husband has taken ATM Card and presently he is demanding deed of my land.

That my husband since my marriage has doubted my character for irrelevant reasons and for such irrelevant doubts/ suspicion he has created immense physical & mental cruelty & torture upon me and degraded my character in society and further he has also harass and humiliated me in front of many persons compelling to take rent/shelter frequently.

That my husband since my marriage has used an abused me by all possible means and presently not only my life is ruined but I am also going through deep mental frustration by the acts and activities of my husband and my in-laws.

You are therefore requested to take immediate drastic legal action against my husband in accordance to law for the continuous physical & mental cruelty & torture caused upon me by my husband, so that the wrongdoers can be punished as per law and your good office is very much concerned in this regard
