PS siliguri would like to Report and FIR for the theft on the shop which has been done by
unknown miscreants man on 15/7/2024 at 5 am which is also recorded on CCTV camera.

Building owner Gopal Majumdar around 8 am accordingly I contacted to our other staff
named 1. Ram babu mahato Phone no.99331-30114, 2. Pranab Dey 98326-70732, 3.
Rony Roy 89440-94226 further also informed the shop owner of the Siliguri dental
goods suppliers over the mobile phone and as per her direction myself along with the
above noted staff visited the shop where it was found that the cash box was damaged
and approx 2.15 lakh rupees was stolen along with the dental materials hyflex EDM
which was around 90 pcs worth Rs approx 2,13,000/- and one mobile phone Samsung
M12 colour blue IMEI no.355644562025292.

Therefore sir kindly investigate in this incident and recover the stolen money, materials
and mobile phone of siliguri dental goods suppliers.
