In producing here with one arrested accused person namely Krishna Barman (25) S/o Sontosh Barman of Rananagar PS Matigara Dist. Darjeeling (Driver) and seized 01 (one) Truck having registration No. WB-73-C-3870 loaded with river bed materials (sand) as per proper seizure list.

In this regards I SI Tanmay Kundu of New Jalpaiguri PS , SPC lodged a written complaint against the above noted arrested accused person to the effect that on 15.07.24 at 00-05 hrs I received source information that some loaded vehicles were seen with carrying riverbed material illegally from Jalpai More side towards Fulbari side, Accordingly I informed the matter to the O.C. NJP PS and also duty officer of PS and as per his direction myself alongwith C/1035 Sontosh Rabi Das, C/1462 Sajjan Tamang, CV-824 Niru Kumar Yadav were left for to verify the veracity of information vide NJP PS GDE No. 1019 dt. 15.07.24. On arrival at Bhanumoti Road near Railway Hospital at 00-35 hrs it was found that the above noted vehicle loaded with riverbed materials (Sand) was coming from Tinbatti More side. I alongwith force detained the said vehicle at Bhanumoti Road near Railway Hospital under PS NJP and apprehended the driver of the said vehicle, on asked he disclosed his name and address mentioned above and found that the said vehicle was loaded with riverbed materials (sand) .On demand the driver of said vehicle failed to produce any documents/papers in favour of the carried substances (riverbed materials) and also failed to produce papers in support of the said vehicle. On further interrogation the above noted accused driver confessed that he loaded the riverbed materials (sand) from the Mahananda riverbed at Kala Bagan under PS NJP illegally with violation of Govt. order vide Memo No. 101/MM/DLLRO/JAL/2024. Dated 01.07.24 issued from District Magistrate & Collector, Jalpaiguri. Thus it is suspected that the organized racket in operation for carrying riverbed materials illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. As such I seized the above noted vehicle loaded with riverbed materials (sand) with proper seizure list and arrested the driver of the said vehicle u/s 35 BNSS after maintaining all formalities of law. The seizure and arrest was done in between 00-40 hrs to 01-05 hrs.

Under the above circumstances, I pray that a specific case may kind be started against the arrested person namely Krishna Barman (25) S/o Sontosh Barman of Rananagar PS Matigara Dist. Darjeeling (Driver) and arrange for its investigation .
