I, **Sri Sukhwinder Singh Bajwa**, Son of Late Jasbir Singh Bajwa, resident of Bhuttabari, Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, Pin. 734014. I would like to inform you that 25.06.2024 I was traveling from Siliguri to Bagdogra with my personal vehicle being no. **WB-90-0650 (XUV 500)** and suddenly a car being No. **WB-74-BN-7753 of Sri Sukamal Das**, Son of Sushil Das, (90640-44177) resident of Ashighar More, Purba Chayan Para, Dist. Jalpaiguri hit my car behind the back side and it was fully damaged the incident took place at **Naukaghat Bridge** at around 7:30 PM. at the time of accident he was drunken condition.

Thereafter I stopped my car and inspected the damages incurred during the collusion of the said vehicle with my car and I charged Sukamal Das then and there for the damages caused by him and to repair it.

That at the time of incident one patrolling van was there on vigilance duty and they came at the said incident spot and then the said Sukamal Das requested me not to proceed any further with any sort of legal actions against him and his cousin brother Mr. Biplab Shil (9641058170) and Sourav Bhaskar (8250715340) called me and also assured me not to take any legal action by way of written statement (annexed herewith) that Sukamal Das will pay for the entire damage caused by him during this accident to me.

But after releasing him from the spot neither he is receiving my call nor tried to contact with me after the said incident. That the said accident was caused by his own negligence and way of rash driving.

Therefore, Sir I am kindly requesting you to look into the matter and take proper legal actions against the said Sri Sukamal Das (90640-44177) , Mr. Biplab Shil (9641058170) and Sourav Bhaskar (8250715340) being vehicle no. WB-74-BN-7753 for such incident caused from his end.
