Sub: Unauthorised set-up of IOC hoarding in the land beside us.

Sir,

I, Nirmal Kumar Ghosh, son of late Ramani Mohan Ghosh, resident of Bimal Sinha Sarani, Hakimpara, Post Office and Police Station Siliguri, District Darjeeling, Pin - 734001 would like to bring into your notice regarding the unauthorised set-up of hoarding using Indian Oil Corporation Ltd. logo in the land beside us, our land bearing Khatian No. 39, R.S Plot No. 510 in Mouza Mandlaguri.

I would like to state that I don't know the authenticity behind putting up a hoarding of such manner that too using Indian Oil Corporation Ltd. Logo. There is no such information regarding such and I believe someone is trying to gain forceful access to the right of that land by putting up such banners and hoardings all of a sudden.

I would also like to state that as per my knowledge, the hoarding is set up by East India Service Station. Their dealership agreement has been terminated by Indian Oil Corporation Ltd. long back and also IOC have surrendered the Explosive License of east India service Station long back. And also there is a letter from East India Service Station to IOC Ltd. stating that they have resited their outlet to a different place and they have purchased that land for the same. All related letters and documents are enclosed herewith along with this letter.

Therefore, I pray to your good office to look into this critical matter on a priority basis and take necessary action upon it at the earliest.
