Subject: FIR against stolen jewellery and cash from marriage function.

Dear Sir/ Madam,

With due respect I, Sibnath Ghosh son of late Nirendranath Ghosh, resident of Ward no. 26, South Babupara, Siliguri would like to state that my daughter's wedding took place at Shivam Palace, Burdwan Road, Siliguri on 30th June 2024. During the event my daughter received some gold jewellery and cash as gifts from around 30 guests. The items were kept in a white bag by my wife and daughter-in-law. As they got away from the stage to attend a ritual an unknown person wearing green blazer, yellow t-shirt, blue jeans and sports shoes got up on the stage and walked away with the bag. We searched the house thoroughly but could not find the above mentioned items and then we went to Kolkata to attend the reception function. On 10.07.2024 on receiving the cctv footage and going through the videos my son was able to identify the robbery. CCTV footage of the person removing the white bag from the stage is handed over in a pen drive for your reference.

I would be very grateful if you kindly look into the matter so that the stolen items can be returned and the culprit receives his due punishment.


