Subject: Complaint relating to the Illegal Trespass and Encroachment on my Land.

Dear Sir/Madam,

With due respect, I Rajesh Kumar Yadav, Son of Late. Banarasi Yadav, aged about 51 years, Resident of Ganga Nagar, Ward No. 05, Siliguri under S.M.C, District- Darjeeling, Pin- 734005, in the state of West Bengal, writing to bring to your immediate attention a matter of grave concern regarding illegal trespass and encroachment on my piece and parcel of plot of land situated at Maharaj Colony, Near Braham Baba Sthan, Ward No. 04 Siliguri under S.M.C, District- Darjeeling, West Bengal, Pin- 734005, which is in my possession and upon which one Civil Suit is pending before the Ld. Civil Judge (Junior Division), at Siliguri titled as **TITLE SUIT CASE NO. 242 of 2019** and it is pertinent to mention here that the Ld. Court has passed an ad-interim order of injunction in my favour and the I/C of Siliguri Police Station was ordered to give a police protection to me i.e., the plaintiff and also the Ld. Court had extended the order of injunction but, I am stunned to see that currently the said plot of land is being encroached upon by a group of miscreants.

That today i.e., on 18/07/2024, I have lodged one FIR before the Officer-In-Charge of Khalpara T.O.P. under Siliguri Police Station at about 10:00 am on the same subject matter, whereby I stated that one person namely Dilip Ray has/have erected a temporary pandal structure on my land without my permission, and the same FIR was accepted and lodged. But, after several inquiries, the name of the main culprits has been revealed. That the said person namely Dilip Ray have/had been induced and motivated by one Binod Paswan, Son of. Late Parmeshwar Paswan, Abhishek Paswan son of Binod Paswan, resident of Maharaj Colony Santoshi Nagar, P.O – Siliguri Bazar, P.S – Siliguri, District - Darjeeling, Jitendra Prasad, Son of Bishwanath Prasad of Ganganagar, Ward No. 05, P.O and P.S- Siliguri, Mayanath Gour @ Final, Son of Raja Ram Gour of Khalai Bhaktri, P.O & P.S- Matigara, Dist – Darjeeling, MD. Azad, Son of Md. Shehzad resident of Basu Colony, Ward No. 04, Siliguri, Dist- Darjeeling, Sumit Mishra, Son of Not Known, Resident of Chanapatty, Ward No. 06, Siliguri, District – Darjeeling, Bimal Biswas, Son of Not Known, Resident of Santoshi Nagar, Ward No. 05, Siliguri, District - Darjeeling in order to illegally encroach the peaceful possession of my land with a mala fide and dishonest intention and they are already an offender and criminal, and the said persons namely Binod Paswan, and others has earlier records of violating the peace, safety and security of local residents. That they have also violated the injunction order as passed/delivered by the Ld. Civil Judge (Junior Division), at Siliguri, several times.

That in view of the above it is important to lodge my complaint today and add the names of the above named accused persons who has/have violated the injunction order and entered into my land illegally by way of criminal trespass as the above named accused persons have not taken any prior permission from me to erect a pandal in my land, which clearly shows their mala fide intention to grab my land, and when I confronted them and asserted my rights, they became furious, aggressive and tried to physically attack me, they threatened me with dire consequences and used filthy and abusive words to me. This situation is alarming and requires urgent intervention from your good office for the interest of justice.

I request you to kindly take immediate strict legal action to remove the pandal structure and illegal encroachment from my land and ensure the safety of myself and my piece and parcel of plot of land. Enclosed with this letter are copies of the Ld. Court's injunction order of injunction and other relevant and necessary documents for your reference.
