Subject: Request letter as First Information regarding theft of Vehicle bearing WB74AX7027

Respected Sir,

I am Gargik Adhikari s/o Gopika Ranjan Adhikari and a permanent resident of Raja Villa, Suryasen Pally, Tulakata, PO Kadamtala, Atharokhai, Shivmandir, Dist. Darjeeling – 734011.

By profession I am an IRDA licensed surveyor, loss assessor cum investigator and as my laptop was not working properly so to make it updated, I visited my known computer expert Mr. Dinesh Diwakar computer shop just below Fancy Hotel Opposite of Biswadeep Cinema, Hill cart Road on 18.07.2024 at around 6 p.m. I kept my bike in front of the building and enter the commercial complex with my laptop.

When I returned back at 10.05 p.m. on 18.07.2024 and searched my bike but it was not present. I hue and cry asking all the nearby people. It was also noticed that one or two other 2 wheelers where also tried by the theft to stole but only my bike was stolen.

Immediately, I contacted Pradhan Nagar PS and discussed the matter with the officer present and immediately police patrolling van visited the spot along with myself and enquired about the bike.

The whole night we searched with all possible places and did not find any clue of recovery. All our efforts in vain so at last now I came to put up a written complaint.

Requesting you sir, to please accept my prayer and do the required legal action to recover and do the needful. The details of the Bike stolen is given below for ready reference.
