dowry then they'll keep me as well with the other women or else they will throw me out of my matrimonial home.

That thereafter on 28/01/2024 at around the evening when I was out for some marketing at the Bagdogra Bazar I suddenly spotted my husband roaming with one women by holding her hand, later at night when he came back and I asked him about the same and suddenly his temper changed to hell resulting in serious verbal abuse which clarify that I was absolutely right about his position of having an illicit relationship with another. When I deliberately protested Against his behavior to his mother suddenly, my mother-in-law and brothers-in-law started as ulting me with fist and blows. My mother in-law pulled my hair from my back and my husband assaulted me heavily in that condition. I somehow managed to skip from their hold and ran out of my matrimonial home to safe my life with both the children.

That thereafter on several occasions well wishers and family members of mine tried to solve the matter in presence of both the family but they never agreed to do the same. Also they were sticked to their inhu nan behaviors as they always do.

That it took me around few no.ths to get recovered from all of these traumas that I have faced in my matrimonial home and I even decided to start my life freshly with Two of my children to ensure a g of future to them but all of a sudden on one day I have received one legal notice Dated: 16/05/2024 which shook me as they were trying to manipulate all of the facts.

That I am an illiterate person having no sort of knowledge or higher reach leading to which I resorted to leave with my mother and Two children but my husband and in-laws are continuously threatening me with dire consequences leading to which I have appeared before you today to help me by taking strong legal action against my husband and in-laws with due course of law.

The said marriage was an arranged marriage. After the said marriage, my husband took me to my matrimonial home, situated at Lala Basti Upper Bagdogra P.S.- Bagdogra P.O.- Bagdogra Dist- Darjeeling.

It is pertinent to mention here that during the time of marriage no dowry was given by my family members and after few days of marriage my in-laws started demanding dowry and some-times they used to taunt me as they have not received any penny from my parents as dowry.

That after the said lawful wedlock two male children namely Master. Ayush Sahani and Master. Aditya Sahani was born on 27/05/2015 and 06/09/2018 respectively at Khoribari Government Hospital, and all the expenses including the hospital bills, foods, nutrients and clothing etc., was beared by my father alone.

That after few days of the birth of my younger child namely Master. Aditya Sahani, my daily schedule was changed. I was engaged in household work and in care of both the children. During the said period, I noticed some behavioral changes in my husband, he started ignoring me in various ways.

That my husband used to run one online café near Bagdogra Panchayat office. The office used to open at about 08:00 am but, I was surprise to see that my husband uses to leave the house early morning. It was just 6 months after the birth of my younger child my husband started coming back late at night which has become his regular habit. On the notable changes on his Officer-in-chargeehavior and timings I inquired him about the same and he remained silent on every
