Jalpaiguri beg to inform you that my marriage was solemnized with Madhu Sudhan Roy (Bipul Roy) of Dakshin Ektiasal, Ektiasal Hat, Ward No. 40 of SMC, P.S. Bhaktinagar, Dist. Jalpaiguri according to hindu rites and customs. Thereafter we started to reside as husband and wife in my above mentioned address and out of said wedlock two sons were borne. After marriage my husband used to assault me on various occasion but I did not lodge any complaint against my husband for the sake of my children. In the month of January 2023 I became seriously ill due to stroke. At present I am not in a possession to move properly but my husband never looked after me so my sisters are looking after me and also taking all types of care. In the month of March 2024 my husband has left the house without informing us. Thereafter on several times I along with my sons called him on his mobile being mobile number 9832335798 but every time my husband replied that he is out of station due to some urgent work and will come within a short period. Thereafter in the month of June 2024 my husband came to my above mentioned house and stated that he again married a women namely Piku Chokrabarty of Gangarampur so he will not reside with us. Thereafter again on 12.07.2024 my husband came to my house at about 7 p.m. and assaulted my sister namely Payal Sarkar. Thereafter my sister lodged a written complaint against my husband on 12.07.2024 to the Ashighar out-post. That today i.e. on 17.07.2024 at about 4 p.m. my husband came to my house and threatened me in presence of my sisters that he will take divorce within a short period and also tried to oust me from my house forcefully but when I raised protest, my husband assaulted me by fist and blow as a result I fell down on the floor and thereafter my husband again assaulted me by kick. My husband further threatened that he will reside in my house with his new wife by ousting me there from.

So I request you to take appropriate legal action against my husband Madhu Sudhan Roy (Bipul Roy) and obliged thereby.
