Sir,

I, Sri Sarna Roy, S/o Late Bhola Nath Roy, resident of Jyoti Nagar, P.O. Sevoke Road, P.S. Bhaktinagar, Ward No. 41 of Siliguri Municipal Corporation, District Jalpaiguri, being the recorded owner of below schedule land, would like to report you the following facts :

That myself is the absolute owner in possession of all that land measuring 4 (four Katta), in sheet no. 9, R.S. Plot No. 28 recorded in Khatian No. 681/5, within Mouza Dabgram, J.L.No.02, P.S. Bhaktinagar, District Jalpaiguri by virtue of registered deed of Sale through registered document No. I- 6348 for the year 1990 executed by one Janakeshwari Roy. That one Deed of Sale, dated 23.04.1969 executed by Kauchuswari Roy in favour of Janakeshwari Roy in respect of 33 decimals with specific boundaries.

That one (1) Asharu Roy Son of Late Subal Roy (2) Asharu Roy's Son (3) Asharu Roy's Jamai son of not known all are resident of Madhya Chayan Para, behind power House, Near Ashighar More, P.S. Bhaktinagar Dist. Jalpaiguri within the your jurisdiction, on 16/07/2024 Asharu Roy and their men and agents and miscreants most unreasonably and unlawfully started to create obstructions in construction work of my below schedule land boundary wall.

But when said boundary wall construction work going on at mid night on 17.07.2024 at about 12.30 a.m. I suddenly got an information over telephone from my local people that one Asharu Roy Son of Late Subal Roy and his son and his Jamai and his associates all are resident of Madhya Chayan Para, along with some other miscreants forcefully trespassed into my above mentioned decreed land and most illegally and deliberately demolished northern portion of the said Boundary Wall, which was newly constructed through on getting such information my son samir Roy immediately rushed to the spot to restrained them then the said (1) Asharu Roy Son of Late Subal Roy (2) Asharu Roy's Son son of Asharu Roy (3) Asharu Roy's Jamai son of not known and others all are resident of Madhya Chayan Para, P.S. Bhaktinagar Dist. Jalpaiguri from demolishing the Boundary Wall, but in the Meanwhile said Asharu Roy and his son and Jamai most illegally demolished the northern side of the boundary wall and even more they have also forcefully taken away goods which were kept within the land premises 10 bag cement bags, Iron rod 8mm (approx 102 kg.), Lohar Karai, Belcha etc. there from my aforesaid land. And when said Chowkidar raised his voice against such illegal activities of Asharu Roy and others then they abused in filthy languages and also physically assaulted him by slapping and blowing on his face and kicking on his

have been making deep rooted criminal conspiracy against me and they have forcibly enter into my valuable land for trying to grabbing my land even they have been violation Ld. Court Order, and they have also threatened me with dire consequences and they have also trying to deceit me by way of cheating by saying he is the owner of this land. All the miscreants are residents of Maddhya Chayanpara within your Jurisdictions. Said Asharu Roy and his son and his Son-in-law and others violation Ld. Court Order.

Sir, presently I am the lawful owner in possession of the aforesaid land measuring 4 Kathas and I am holding and occupying the said land by paying land revenue/khazana to the state of West Bengal through the office of the B.L. & L.R.O. Rajganj and no one has any right to whimsically demolished any portion of boundary wall and any portion of my lawfully purchased land.

Sir, in view of the above stated facts and circumstances, I therefore most humbly pray before your good office to take immediate and appropriate legal action against said (1) Asharu Roy Son of Late Subal Roy (2) Asharu Roy's Son S/o Asharu Roy (3) Asharu Roy's Jamai S/o not known all are resident of Madhya Chayan Para, P.S. Bhaktinagar Dist. Jalpaiguri and others miscreants and prosecute them before the Court of Law as per legal provisions as early as possible.
