Dear Sir/Madam,

M. Manila Saha (Roy Chowdhury), daughter of late Parimal Roy Chowdhury is informing you regarding the tragic incident involving my father, Parimal Roy Chowdhury who was struck by an unknown toto on the evening of 1st July 2024. Briefing the incident as follows: my father was a resident of Deshbandhupara, (Michael Madhusudhan Dutta Sarani, near Tarai School ground, ward no. 30) aged 87, was hit by the toto on 1st July and sustained severe injuries, particularly a critical brain injury that ultimately led to his passing on the evening of 8th July 2024. He was out for his regular evening walk but never returned, and then at night, we found him at the hospital.

The toto driver, whose identity remains unknown, transported my father to the hospital around 7:50 pm with the assistance of a man residing near the hospital gate. Despite being admitted promptly and receiving medical care at multiple facilities, including being placed on life support and a ventilator, my father succumbed to his injuries after seven days. All mentioned above have been already informed to you. I couldn't lodge the necessary documentation for case filing as I was observing the last funeral rites.

Regarding the same I had lodged a diary on 2nd of July. I am willing to cooperate fully and provide any additional information required to expedite the investigation.

I trust that you will handle this matter with the seriousness and urgency it warrants. My family and I seek justice and hope that no other family has to endure such a loss due to reckless behavior on the roads.

Thank you for your attention to this matter.
