Sub: Complaint against Smt Gagan Preet Kaur

I, Sri Suvajit Chowdhury, son of Sri Ajit Chowdhury, resident of Panchayat Road, Shivmandir, Kadamtala, P.S.- Matigara, District- Darjeeling intend to lodge this complaint to the effect as under-

On 13.07.2024 at around 11am to 11.15am woods measuring 938 CFT was schedule to be loaded in the truck bearing DL-1GE-0799 from Basserra Woods, Best Eastern Business House Pvt. Ltd, Sawmill Canal Road, Fulbari-2, Laxmi Jot, District- Jalpaiguri, Pin- 735135 to arrive at Delhi with all valid/legal documentation done before prior the loading procedure with Smt Gagan Preet Kaur, daughter of not known owner of the aforesaid sawmill. Subsequently after all valid documentation the woods were started to be loaded. Within 15 mins of the loading procedure, the manager of Smt Gagan Preet Kaur namely Sri Swapan asked to stop the loading without and specific reason and further stated that the same has been instructed by Smt Gagan Preet Kaur. I asked said Sri Swapan to explain me the reason in writing to which he denied. Thereafter upon a cordial conversation of Sri Swapan he further asked to continue the loading and almost 50% of the loading was being done. At around 1.30pm to 1.45pm in the afternoon after the worker came back from their lunch to continue the loading procedure Said Smt Gagan Preet Kaur in a few mins arrived at the sawmill in an intoxicated state and started to misbehave with other staffs present in the sawmill during that said time. Suddenly said Smt Gagan Preet Kaur approached me using abusing words and threatened me she would stop the loading. Upon asking her the reason she tried to pull my collar and kept giving me unnecessary threats and inappropriate words in her intoxicated state. Suddenly when said Smt Gagan Preet Kaur lost all her civility and humiliated me with bad gestures and languages and threatened me involve me into false cases one of my family friend, Smt Debjani Das who was there with me since morning during the entire loading procedure, she tried calm down Smt Gagan Preet Kaur. Said Smt Gagan Preet Kaur assaulted Smt Debjani Das by chocking her neck and

started to pull her attire before all male co-workers and snatched the gold chain Smt Debjani Das was wearing measuring approx. 15gms to 17gms which she was wearing during the incident. Said Smt Gagan Preet Kaur in an intoxicated nature assaulted said Smt Gagan Preet Kaur to which she has sustained injuries and later had to take tetanus at Siliguri Hospital the same day. Said Smt Gagan Preet Kaur kept using abusing languages towards me and defamed my reputation between other co-workers and staffs present there. Thereafter finding no other alternative I had to call one police personal from N.J.P. Police Station and the matter came under control later. Since then, said Smt Gagan Preet Kaur has been giving me threats to involve me into false cases. The entire incident was video recorded during the occurrence of the incident. I could not immediately lodge and complaint on the same day as the loading procedure was already delayed by Smt Gagan Preet Kaur illegal and inhuman activities and as the loading procedure has to be completed within time I was engaged with the completion of the procedure.


Hence. I am requesting your good office to register this complaint and take prompt action against Smt Gagan Preet Kaur for her abusive behaviour, languages and gestures towards me.
