P.S-Siliguri, Dist-Darjeeling, do here by Lodge this written F.I.R Before You To the
Effect Stating That on dated-20/07/2024 around 4 am at morning I was return home
from a reception Party on that time at hill cart road, Near paan palace some
anti-social elements almost 4 to 5 boys who are stay near by shop ,they suddenly
they stop my scooty bearing no-WB-74-MH-1285 then had taken some sharp weapon
Khukri ,iron punch and wooden stick ,a boy namely was Sahnawaz he put khukri
on my neck and starting snatched my money almost 5250 cash ,gold chain, gold ring
when they try to snatched my scooty key and i try to stop them then they suddenly
started beaten me badly with stick and iron rod, one of the boy sahnawaz and
chocolate(nick name) they attack on my head with a sharp khukri , causing to that I
got deep cut in my head ,due to deep injury blood was swelling over my head but
they did not stop and beat me by the iron rod, they take my scooty and ran away
when I called my friend they came and take me to district hospital for treatment In
that time they again reached at the district hospital near emergency gate they stop us
and again started beat us the whole incident has been recorded in C.C.T.V Footage
of District hospital. When I was senceless then they run away. They take my scooty
also , the hospital staff take me to emergency ward where doctor treat me. In this
incident i got grievous injury on my head ,chest, back and stomach. I got five stitches
