I, Dr. Sanjib Sarkar, son of Late Bimal Kumar Sarkar Facility Director of Ncotia Getwel Multispecialty Hospital, Siliguri, situated at Uttorayan Township, behind City Centre, Matigara, Darjeeling Dist.- Darjeeling, would like to inform you the following facts and circumstances:-

At the outset I would like to state that the patient namely Mr. Ripan son of Bimal Dutta R/O Rabindra Pally, Bidhan Nagar, Lahugaon, Budharugaon, Kalachandgach, Darjeeling, West Bengal PIN-734426, is a 48 years old male patient admitted on 09/07/2024 for medical treatment at our hospital i.e. Neotia Getwel Multispecialty Hospital. The patient was assigned MRD no. UHID.101107131 and after providing the best medical treatment the patient was discharged on LAMA (Leave Against Medical Advice) i.e. on 19/07/2024.

It is pertinent to mention here that the total bill including medicines, hospitality facility and allied services provided by our hospital for the treatment of the aforementioned patient is for an amount of Rs. 2,64,011. (Rupees Two Lakh Sixty-Four Thousand and Eleven only) The patient and /or his wife Smt.
