Sir,

I, Priyanka Singh, age about 33 years, W/O, Ritesh Kumar Jain, Presently residing at Jyoti Nagar Siliguri, P.S-Bhaktinagar, Jalpaiguri and permanent resident of Amrapali sapphire sector 45, Noida, Gautam Buddha Nagar, Uttar Pradesh- 201303, lodge the Complain to the effect that on 19/07/2024 at about 11:00 Pm. my husband namely Ritesh Kumar Jain, age about 44 years resident of Jyoti Nagar Siiguri, P.S-Bhaktinagar, Jalpaiguri and permanent resident of Amrapali sapphire sector 45, Noida, Gautam Buddha Nagar, Uttar Pradesh- 201303 was coming towards our residence by riding Scooty vide Reg.No.UP38AA7963 from Check Post market by taking Own Side and in a moderate speed at the relevant time when he reached near Tarai Blood Bank (Jyoti Nagar) all of a sudden a vehicle bearing Registration No. WB 74 AM 7676 coming from the same direction, being driven quite rashly, negligently, utmost high speed lacking proper lookouts and observance very violently and bluntly dashed the Scooty vide registration UP38AA7963 from behind as a result of which, my husband fell down on the road and received serious, grievous and multiple injury specially over his head, then and there local people rush to the spot and took him to Ananda Lok Hospital, but the attending Doctors declare him as brought dead.

The accident took place due to rash and negligent driving of the driver of the vehicle bearing Registration No. WB 74 AM 7676 and he was solely liable & responsible for this accident.

The causes of delay to lodge the complain as I was busy for the customary rituals and suffering from mental depression.

So it is therefore prayed that you may kindly take necessary action against the driver of the vehicle bearing Registration No. WB 74 AM 7676.
