

That said SRI. TAPAN KUMAR SAMANTA with intent to cheat and misappropriate my money induced me with false promise and assurances to this agreement and thereafter intentionally violated the same only to misappropriate my huge amount of money.

I will be highly obliged if you kindly consider the case and take appropriate action against the said SRI. TAPAN KUMAR SAMANTA.
