I would bring to your notice that I Sijit
Choudhury s/o Mr. Madan Mohan Choudhury r/o
Kalamjote P.O. Subrata Nagar, P.S. Matigara
that one Mr. Amar Ghosh s/o Makhan Ghosh
r/o Shantiniketan, Block 19, flat no. 4E and
Mr. Jectu Thapa r/o Kalamjote had physically
assaulted me today (22nd July, 2024), the
reason being me asking for my vehicle
since months (approx. 9 months) to return the
same. The request was time again denied
by them. Either they had sold my bike or
they have malefide intentions to not return
the same.

me which had significant head and injuries
which has also been medically acknowledged by
the doctors seeing me.
