Sir/Madam,

I the undersigned would like to inform you that I and the companies of the same married wife of Sri Pritam Saha, son of Late Goutam Saha of Bharat Nagar, Near Tarun Tirtha Club, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling. Our said marriage was solemnized on 09.03.2023 in my paternal house at Shanti Nagar, P.S. Bhaktinagar, Dist. Jalpaiguri according to Hindu rites and customs. At the time of the said solemnization of the marriage, as per the demand of my husband and mother in-law namely, Smt. Pratima Saha, my father had given furniture, gold ornaments, utensils, electronic and cash amounting Rs. 50,000/- (Rupees Fifty Thousand Only) to my husband.

After the said marriage, I was brought by my husband in my matrimonial house as stated above along with the above mentioned stridhan articles. After elapsing of few days from the date of the said marriage, my husband and my mother in-law have started to put pressure upon me to bring money from my father for the purpose of fittings of running water in my matrimonial house and they somehow compelled my father to pay a sum of Rs. 40,000/- (Rupecs Forty Thousand Only) for purchasing a water pump, water tank, pipes and other accessories for installation of the said machineries in my matrimonial house.

I would like to further inform you that on one occasion, my husband and my mother in-law directed me to handover my valuable gold ornaments present market price worth Rs. 5,00,000/- (Rupees Five Lakhs Only) which were given by my father at the time of the said marriage as per the demand of my husband and my mother in-law with a plea for the safety and security of those valuables and on good faith, I was convinced and entrusted the same to them.

I would like to further inform you that after elapsing of few months from the date of the said marriage, I noticed that my husband and mother in-law have started to make the comment regarding my stridhan properties and I understood that they were not satisfied with the quality and quantity of the said articles and those were not in accordance with their expectation and on few occasions they made the comment that my husband is the only son and he can get the more and handsome dowry if he would marry elsewhere but being the newly wedded wife, I swallowed all those intentional and humiliating comments and thought that the matter will be resolved with passage of time but within few days I realized that I was completely wrong when they started to put pressure upon my father to purchase a flat in the name of my husband as because the present residential house and its accommodation is not sufficient but my father is a carpenter by profession and he has a limited income and he tried to convince my husband that he is not able to purchase a new flat but my husband and mother in-law compelled my father to give a sum of Rs. 2,40,000/- (Rupees Two Lakhs Forty Thousand Only) for renovation and repairing and they have given an ultimatum to my father for arranging the money for purchasing a new flat as early as possible.

I would like to further inform you that my husband did not pay a single furthering to me as my personal expense on and from the date of the said marriage and on one occasion, I tried to convince him that it is very looking odd to demand the money for my personal expense from my father but I got astonished when he told me in reply that to earn money indicating as call-girl and on the other hand my mother in-law she doesn't allow me to enter into the kitchen for having my food as because she used to serve the food with a very limited quantity and whenever i asked for the sufficient food, she used to tell me that "sala bikharir bacchar pet bharate give aamra bikhari hoy gelam" and also she used to abuse filthy languages which cannot be uttered in a circlized society.

I would like to further inform you that gradually my husband and my mother in-law have accelerated the quantum of torture upon me for compelling my father to purchase the new flat and due to non-fulfillment of the said demand, my mother in-law asked me to sleep alone by giving the open threat that till the purchase of the said flat, I

will not allowed to sleep together with my husband and she ascertained the said punishment.

I would like to further inform you that on 07-06-2024 my mother inlaw has started quarrel with me on that issue of purchase of flat and started to abuse filthy languages and on protest she throttled my neck and I sustained injury and somehow I managed to rescue myself from her grip and informed the matter to my husband but he also took the stand on the side of his mother and ultimately I came to my father's house on that day and till that my husband did not any communication with me and also he avoided to attend my phone calls and ultimately yesterday i.e., on 20.07.2024 I along with my father, elder sister and her husband went to my matrimonial house but after seeing us, my mother in-law closed the main door on our face and did not allow to enter into the house by abusing filthy languages and ultimately we started to turn for returning in the mean time my husband has suddenly attacked me and started to assault me by kick and blow and for that I fell down on the earth and sustained injury and my elder sister and her husband tried to save me but my husband has also assaulted them by pushing my sister intentionally and due to my hue and cry, local people came and gathered there and seeing the said local people, my husband fled away from there. Thereafter, I went to Siliguri District Hospital for my treatment.

Under the above circumstances it is humbly requested to you to kindly investigate the matter and do the needful for the ends of justice.
