It is pertinent to mention that the accused Sri Samar Roy is also missing since yesterday.

My daughter is of very tender age hence I request your good office to take necessary

measures to recover my minor daughter and arrest the miscreant i.e. Sri Samar Roy.

Please treat this as very urgent and act accordingly.


