Dist - Darjeeling, Pin - 734011, beg to state as follow: -

1. That Rina Singha D/o - Bisadhu Singha resident of
Salkavita, P.O - N.B.V, Dist - Darjeeling, is sitting in front of
my Entrance gate from 22.07.2024 till date with the
help of her some antisocial persons (friends) and demanding
Rs. 10 (Ten) lacs from me and sending offer from several
sources. From five ^{days} she is continuously torturing me and
my family members mentally. Thus we are out of my
house for 5 days. They also assaulting with filthy language
and throwing stone to my house.
2. That today at 8. p.m Rina Singha, Bisadu Singha,
Bikash Singha, some antisocial persons (friends of -
