I ASI Bikash Roy of Matigara PS do hereby lodged written complaint to the effect that on 25.07.2024 I was engaged in performing evening Mobile Patrolling duty (K-32 -II) with Const. 989 S.N. Ghosh, CV - 783 Nirod Singha vide CC No. 1323/2024, dated- 25.07.2024, this refers to Matigara PS GDE No. 1954, dated- 25.07.2024. At about 20:00 hrs I received information from duty officer of Matigara PS ASI Abdul Latif that some unruly mob attacked in the house of Sanjay Singha, S/O Lt. Piyaju Singha of Tulakatajote, PS- Matigara, Dist- Darjeeling. Accordingly, myself along with force rushed to the spot and found that above noted accused persons under the leadership of Rina Singha forcefully entered into the house of Sanjay Singha by breaking open the main Iron gate also damaging the house hold properties. I gave them warning not to take law in their own hand and to disperse from the spot. In spite of my repeated warning the unruly mob paid no heed to my warning and turned deaf ears. I tried hard to pacify the situation and to bring situation under control but the above noted accused persons along with 30/40 others attacked upon us. They started scuffling with the Police personal, assaulted us, lastly broke down the windshield of Govt. (Police) vehicle Reg. no. WB - 77 4756 by pelting stone. Thus they restrained us to discharge our Law full Govt. duty, assaulted on duty Police personal also damaged the Govt. property. Accordingly, I seek re-enforcement from Matigara PS. After reaching of re-enforcement from Matigara PS I manage to arrest the above noted accused persons u/s 35(1) of BNSS from the spot where 30/40 others managed to escape from the spot.

Under the above circumstance, I pray before your kind honour that a specific case under proper section of Law may kindly be initiated against the above noted arrested accused persons and to arrange for its investigation.
