Township want to inform you that- on 24-07-24 at
11:15 PM my brother's phone was snatched by few
goons on running after them to get the phone back
by my son Souvar Mandal 200 mtrs away from my
house my son took back the phone from them &
in the mean time while everyone would reach there
my son Souvar Mandal was badly physical Assaulted
with sharp objects, stone & others with several
head injuries & other body injuries. My son was
attempted to murder with multiple sharp objects
by several goons out of which 5 of them was identified
named ① Talbij Khan s/o Humayun Khan ② Parvej Khan s/o
Humayun Khan ③ Akbar Khan s/o Humayun Khan ④
Rappu Khan s/o Selim Khan ⑤ Sobel Khan s/o Parpiya Khan.
Sir I have admitted my son to North Bengal Medical
College & Hospital for his serious condition & necessary
investigations are going on.

Sir I therefore request you to kindly look into this
matter and take necessary action at the earliest.
