Respected Sir,

As per the judgement of honourable Calcutta High Court, Circuit Bench at Jalpaiguri in the WPA 315 of 2024, passed on 08.07.2024, Mr. Malay Laha Vs The Pradhan, Aatharo khai Gram Panchayat & Ors, the execution of proposed shifting work has already been started on 12.07.2024 at 11:00AM at the site Shantipur, near Halermatha, Shivmandir. Yesterday i.e. 22.07.2024 when the workmen of entrusted agency approached the same spot for executing the remaining work, the double pole structure which was erected on previous day i.e. 12.07.2024 has been found completely damaged and left by some unknown miscreants. As the deadline of the compliance of the work i.e. 26.07.2024 approaches, this nuisance has not only caused damage to the property but has also delayed the execution process.

It is also to be noted that the these poles cost approximately Rs. 20397.00 as per Cost Data (2023-24) of WBSSEDCL.
