Sir,

With due respect and humble submission I ASI Kanak Das of Matigara P.S. do hereby lodge this written complaint to the effect that today on 31/07/2024 I was deputed to perform Evening Mobile Patrol duty along with force, since 14:00 hrs to 22:00 hrs vide Matigara P.S. C.C. No. 1289/24, Dated 31/07/24 and Matigara P.S. GDE No. 2301, Dated 31/07/2024. At about 15:00 hrs, in course of said mobile van duty I received source information that few Trucks were moving, loaded with River bed materials, which were procured clandestinely. This is to be noted here that an order has already been passed by the District Magistrate Darjeeling to stop all mining operations on River bed during Monsoon season, vide No. 62/M&M/XIII/DLLRO-DJ/24, Dated 28/06/24. On receipt of such information, I along with my accompanied force had been to Fulbari Patan Road under P.S. Matigara and found one Blue coloured 06(six) wheeler Truck, having Regn. No. WB73C3924, loaded with River bed materials is moving towards Sukuna from Fulbari Patan More. Accordingly I stopped that vehicle at Fulbari Patan Bridge and asked the driver to produce necessary documents in respect of loaded River bed materials. But the driver could not produce any valid documents in respect of such load of River bed materials. It is evident that driver of the vehicle somehow procured the said River bed materials clandestinely, violating Govt. Order, also without paying any revenue to the Govt.

Finding no other alternatives, I seized the said vehicle bearing Regn No. WB73C3934 under proper Seizure List under coverage of Videography, arrested the accused driver namely Bir Bahadur Rai (43) S/O Surya Kumar Rai of Rangmuk T.E, Sider Division, Jorebunglow, Sukhiapokhri, Dist.- Darjeeling, also brought the seized vehicle along with arrested driver at P.S. The seizure was made in between 15:35 hrs to 15:55 hrs.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver of the seized vehicle bearing no. Regn No. WB73C3924 and arrange for it's investigation.
