With due respect and humble submission I ASI Kanak Das of Matigara P.S. do hereby lodge this written complaint to the effect that today on 31/07/2024 I was deputed to perform Evening Mobile Patrol duty along with force, since 14:00 hrs to 22:00 hrs vide Matigara P.S. C.C. No. 1289/24, Dated 31/07/24 and Matigara P.S. GDE No. 2301, Dated 31/07/2024. At about 20:25 hrs, in course of said mobile van duty I received source information that one Dumper loading River bed materials at Baniakhari Ghat under Matigara P.S., taking the advantage of Dark Night. This is to be noted here that an order has already been passed by the District Magistrate Darjeeling to stop all mining operations on River bed during Monsoon season, vide 62/M&M/XIII/DLLRO-DJ/24, Dated 28/06/24. On receipt of such information, I along with my accompanied force rushed to Baniakhari Ghat, P.S.- Matigara, and found one Dumper bearing Regn. No. WB73E2234 is loading River bed materials at Baniakhari Ghat clandestinely. On seeing Police party all the labour and driver of said vehicle fled away towards deep flow of Balason River. I tried hard to search the driver or owner of the Dumper bearing no. WB73E2234 loaded with illegally procured River bed materials but failed. It is evident that driver of the vehicle somehow procured the said River bed materials clandestinely, violating Govt. Order, also without paying any revenue to the Govt.

Finding no other alternatives, I seized the said vehicle bearing Regn No. WB73E2234 under proper Seizure List in presence of local people under coverage of Videography, also brought the seized vehicle at P.S. The seizure was made in between 20:40 hrs to 20:55 hrs

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver of the seized vehicle bearing no. Regn No. WB73E2234 and arrange for it's investigation.
