Subject: Request for Immediate Action Against Illegal Activities on Disputed Land

Respected Sir/Madam,

I, Raghunath Kar, son of Late Mahendra Nath Kar, and husband of Krishna Kar, residing at Ward No. 40, Sachitra Paul Sarani, P.S. Bhaktinagar, P.O. Haiderpara, District Jalpaiguri, would like to bring to your notice a critical issue concerning a piece of land owned by my late mother, Mira Rani Kar. The details of the land are as follows:

- **Area:** 1 Katha 12 Chatak
- **Location:** District Jalpaiguri, Additional District and Sub-Register Office Rajganj, P.S. Bhaktinagar
- **B.L. & L.R.O:** Rajganj, **Pargana:** Baikanthapur, **Mouza:** Dabgram
- **R.S Sheet No:** 8
- **Khatian No:** 701/5 (R.S)
- **Plot No:** 578
- **Total Land Area:** 3 Katha 8 Chatak (Undivided)
- **Boundaries:** North - Passage, South - Land of Raghunath Kar, East - Land of Arup Majumdar, West - Main Road.

This land is currently under dispute, with a court case (Case No. 366/2022) ongoing in the Jalpaiguri High Court. The next hearing is scheduled for 23/09/2024, and as of now, the court has not delivered a verdict. The land remains undivided and unpartitioned.

On the morning of 30/07/2024, Mr. Tushar Kanti Bose, husband of Rama Bose, along with a group of individuals, illegally entered this disputed land. They began cutting down trees and plants, causing significant environmental damage. When we tried to stop them, they threatened us with weapons, warned us of physical harm, and continued their illegal activities, intimidating us further.

Moreover, Mr. Tushar Kanti Bose and his associates are falsely claiming ownership of the land using forged documents, alleging that the land was gifted to them. These claims are entirely false, as the documents lack the necessary witness signatures from any of our family members and are completely fabricated.

Given the severity of the situation, I request your immediate intervention to halt these illegal activities and ensure our safety. We seek your protection and assistance in maintaining peace and security on the disputed land.
