Sub: Complain against (1) Bikram Tewari C/O- Meghnath Tewari Address-Bidhan Market, Siliguri, Darjeeling (2) Sukhen Das C/O-Shibu Das, Address-Bidhan Market, Siliguri, Darjeeling (3) Jiwan Kumar PakrelC/O Tilak Chandra Address- Sevoke Road, Bhaktinagar, Jalpaiguri for alleged forged deed vide no 9863 dt-29.12.1994 at Registration Office- ADSR Rajganj.

In connection with the afore mentioned subject and reference, it is brought to your knowledge that -

- 1.) The Mutation Case No MN/2022/0701/25281 dt-23.09.2022 was executed by the then BL&LRO Sri Subhabrata Mitra in favour of the petitioner Bikram Tewari C/O- Meghnath Tewari Address-Bidhan Market, Siliguri, Darjeeling by creating LR Khatian No. 150, Area 0.278 acres, Mouza- Dabgram, Sheet No-26, LR Plot No-19, Block-Rajganj on the basis of a Deed No. 9863 dt-29.12.1994 at Registration Office- ADSR Rajganj and notice was issued by Sri Manoj Kumar Sarkar, Revenue Officer as per information available in present online e-Bhuchitra Portal. (The copy of document printed from the portal alongwith Order Sheet are enclosed in **Annexure-A**)
- 2.)Mutation Case No MN/2022/0701/25282 dt-23.09.2022 was executed by the then BL&LRO Sri Subhabrata Mitra in favour of the petitioner Sukhen Das C/O-Shibu Das, Address-Bidhan Market, Siliguri, Darjeeling by creating LR Khatian No. 151, Area 0.279 acres, Mouza-Dabgram, Sheet No-26, LR Plot No-19, Block-Rajganj on the basis of a Deed No. 9863 dt-29.12.1994 at Registration Office- ADSR Rajganj as per information available in present online e-Bhuchitra Portal. (The copy of document printed from the portal alongwith Order Sheet are enclosed in **Annexure-B**)

On receiving prayer from Sri Binod Kumar Gupta (Director of Tirupati Heights Private Limited) the then BL&LRO Sri Subhabrata Mitra send letters to the ADSR, Rajganj and ADSR, Jalpaiguri for the verification of Deed No. 9863 for the year 1994 vide Memo No. 2247/BLLRO/RAJ/2023 dt-13.07.2023 & Memo No. 2245/BLLRO/RAJ/2023 dt-13.07.2023 (Copy of the prayer along with the Memos are enclosed in Annexure-D)

As per report received from Addl. District Sub-Registrar (ADSR), Rajganj vide Memo. 911/ADSR/RAJ dt-21.07.2023 by the then BL&LRO Sri Subhabrata Mitra, it appears that the last deed number registered in his office in the year 1994 is 4328. (Copy of the Memo enclosed in Annexure-E).


As per report received from Addl. District Sub-Registrar (ADSR), Jalpaiguri vide Memo. 431/ADSR/JAL dt-26.07.2023 by the then BL&LRO Sri Subhabrata Mitra, it appears that the last deed number in his office in the year 1994 is Deed No. 3708. (Copy of the Memo enclosed in Annexure-F).

Hence, it appears that the Deed No as reported by the Addl. District Sub-Registrar (ADSR), Rajganj as well as by the Addl. District Sub-Registrar (ADSR), Jalpaiguri is not matched with the Deed mentioned in the said mutation cases.

Therefore, the alleged Deed No 9863 dt-29.12.1994 became suspicious and for that reason a proper investigation is required whether the above Deed is forged one or not.

My higher authority is of the opinion that FIR should be lodged in this regard, vide Memo No-116/LAWDLLRO/JAL/2024 dt-23/07/2024 of the ADM & DL&LRO, Jalpaiguri (Copy of the Memo is enclosed in Annexure-G).

Under this circumstances, i request you to investigate the matter and take legal action against the culprits as per law.
