Respected Sir,

I, SRI CHANDAN DEY, Son of Sri Prolay Kumar Dey, resident of Sagina Mahato Road, Shraban Nagar, Ward No. 18 of S.M.C., Siliguri, P.O. and P.S. - Siliguri, District - Darjeeling, PIN - 734001. That today at about 10:40 A.M. when I was returning with my wife from our daughter's school from Hakimpara towards my abovementioned residence by scooter, at that time one Chittaranjan Dutta, son of Jagadish Chandra Dutta, resident of Kuti Mill Road, Dakshin Shantinagar, Siliguri, hit our scooter with his scooter having Registration No. WB 74 AE 9551 and the said Chittaranjan Dutta having Driving Licence No. WB73 2014 0250945, at Hati More and we fell on road. That from the very inception of the said incident abovenamed Chittaranjan Dutta started physically assaulting me with kicks, blows and slaps, and seeing my such condition my wife tried to protect me from the hands of the said Chittaranjan Dutta, and in due course of that process the said Chittaranjan Dutta also assaulted my wife, namely - Smt. Puja Dey and further abused her with dirty and filthy words. That thereafter hearing our cry for help we were rescued by local interference. That thereafter I was taken to Siliguri District Hospital for treatment, and presently after the incident I am extremely stressed and traumatised.

Hence, it is prayed before your goodself to kindly look into the abovementioned matter and after proper enquiry take necessary actions against the said Chittaranjan Dutta as per the due process of law for the ends of justice.
