This is to inform you that I Sumitra Devi Singh age 62 wife of Late Ashraf Singh, residence of Khalpara town out post, Kumabar Patti, ward no. 7 want to inform you that yesterday 27<sup>th</sup> of July around 9 pm in my residence I was sitting in my room and was talking to somebody in mobile phone and suddenly heard some loud noise and I came out of my room and saw that some one was talking to my daughter in law (Sumita Singh) and my grand childrens (Dipika Singh and Aranya Singh) I suddenly realise that he was the person who visit regularly to my house in late night but I don't know his name and address he must be my grand childrens friend I just told him who are you and "did you come here everyday in night time by hearing my words that person went out of my house and suddenly my grand childrens and daughter in law started shouting at me and started beating me with stick and umbrella and my Grand

Children Dipika Singh slapped me and bit me in my thumb and it started bleeding badly and I ran out of my house for help towards Khalpara Thana and the police suggested me to go for treatment and however manage a toto and reached Siliguri district hospital for treatment where I fell down and become senseless for few minutes as my condition was not so good I called my only daughter Kavita Mondal who lives near Askun Road and she came and give me water and medicine with the help of doctors and after that I went to my house for rest and asked my daughter to go home but after few hours when I was alone in my room and taking rest they again attacked me and started beating me and again I went out of my house and slept in my relative house and today morning I went to my house and again they started beating me. Now I am in very much fear I think they want to kill me I don't want to go to my house I am in relative house most of the time no body is helping me to get out of this situation I have complain Khalpara town out post, Siliguri Mahila Thana, DSP office but no action has been taken.

this incident has not happened first time several time they have beaten me and several time I have lodge a complain but no strict action has been taken. I believe if strict action would have been taken then they never beaten me again and again..

So, I request you to take some serious action against them from this time otherwise next time they will kill me.
