Sir,

In producing herewith 03 (Three) arrested accused persons namely (1) Mangal Ghosh @ Pocha-22yrs s/o Lt Sunil Ghosh Gowala patty, Ward No-4, PS Siliguri Dist Darjeeling (2) Bigen Tamang-28yrs s/o Tshring Tamang of Upper Bus stand near SUMI School Kalimpong, PS Kalimpong Dist Kalimpong and (3) Sukumar Das-30yrs s/o Gouranga Das Charak Math Ward No-4 PS Siliguri Dist Darjeeling arrested on 30.07.24 u/s- 35(1) of BNSS along with following seized articles viz: -

1. One iron made sword measuring about 30 inch with butt (approx) from the possession of accused Mangal Ghosh @ Pocha which was kept on his right hand.
2. One iron rod measuring about 23 inch (approx) from the possession of accused Bigen Tamang which was kept on his right hand.
3. One iron knife with wooden butt measuring about 13 inch (approx) from the possession of accused Sukumar Das which was kept on his right hand.

I, ASI Rabin Lama of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 29.07.24 at 22.15 hrs received a sources information that 11/12 youths have assembled at Tikiapara, Rail quarter (Abundant) under Siliguri PS for making preparation to commit dacoity in a house at Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No1607 Dated 29.07.24 Subsequently after sharing the information with my superiors and as per their direction, at 22.20 hrs myself along with SI Srimanta Chatterjee, PSI Koushik Raha C/160 Soumen Sarkar, CVF/622 Ramanath Barman & CVF/283 Prasenjit Dey along with ASI Debesh Mondal, with his force (Van officer) kits left for the place to work out the information. This refers to Siliguri PS GDE No-1608 dated 29.07.24.

We reached at 22.30 hrs on 29.07.24 and waiting there, subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 03 (three) accused persons along with seized articles as mentioned above. However, the other 7/8 persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Siliguri PS area. They also stated that one (1) Bishal Routh, (2) Md Mojabir s/o Lt Md Atabul, (3) Badal Rongdar (4) Niki Das (5) Subhash Barman (6) Shambhu Roy @ Chokfola and two others were fled away from the spot.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between on 29.07.24 at 23.40 hrs to on 30.07.24 at 00.20 hrs) Thereafter, I arrested the above noted accused persons u/s 35 (1) of BNSS under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them. The process of search & seizure has been audio & video graphed at the PO.

I accordingly brought the arrested accused persons along with seized articles at Siliguri Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit Dacoity in a house at Siliguri PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Mangal Ghosh @ Pocha-22yrs s/o Lt Sunil Ghosh Gowala patty, Ward No-4, PS Siliguri Dist Darjeeling (2) Bigen Tamang-28yrs s/o Tshrinh Tamang of Upper Bus stand near SUMI School Kalimpong, PS Kalimpong Dist Kalimpong and (3) Sukumar Das-30yrs s/o Gouranga Das Charak Math Ward No-4 PS Siliguri Dist Darjeeling and (1) Bishal Routh, (2) Md Mojabir s/o Lt Md Atabul, (3) Badal Rongdar (4) Niki Das (5) Subhash Barman (6) Shambhu Roy @ Chokfola and two others and arrange for its investigation.
