Respected Sir,

I, **SRI NILKAMAL KARMAKAR**, Son of Late Nonigopal Karmakar, resident of Telipara, 2 No. Dabgram, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to draw your kind attention to the very effect that my younger brother namely Kalyan karmakar who is a Goldsmith by profession aged about 34 years married having a 2½ years son. On 30/07/2024 at around 12.04 AM when my said younger brother was shopping/interacting at a grocery shop situated near Sanghashri Club Subhaspally Main Road (Kabi Guru Sarani), one dark coloured Hyundai i20 4 wheeler vehicle heading towards the Hatimore, Subhaspally under high speed was most recklessly hit him from side end. After the said accident, the alleged vehicle driver fled away from the spot under high speed without look back to my brother and my younger brother received several brutal injuries and immediately with the aid of local available people, he was brought to Siliguri District Hospital and thereafter on observing the gravity of his injuries, the attending Doctors referred him to North Bengal Medical College and Hospital for better treatment. Right now, he is admitted at SCW Male Ward Bed No. M18 and is fighting with the death. The alleged vehicle along with it's driver can be traced through the surrounding area CCTV footage and the same need to be done under emergent manner for providing justice against such inhumanic deed of the alleged vehicle driver towards my said younger brother, his wife and his little son. My younger brother received irrecoverable injuries for which justice for such act is the need of the hour. Due to the seriousness of his health and not having the stable mental condition to move, the delay to file the present complaint held.

I am, therefore, requesting you to take appropriate legal action/s against the said unknown Driver of dark coloured Hyundai i20 vehicle by initiating specific case and put the wrong doer behind the iron bars for the proper administration of justice.
