I Rani Balmiki, Wife of Sanjay Balmiki, resident of Suryasen Colony, Block – D, beside Ram Dev Mandir, Ward No. 34, P.S. N. J. P., Dist:- Jalpaiguri, begs to state as follows:-

1. That I got married to said Sanjay Balmiki (my husband) on 28/11/2021 and my marriage was an arrange marriage.
 2. That my father died before my marriage long years back and the entire expenses of my marriage was taken care by my mother namely Bimla Balmiki.
 3. That in my marriage my mother gave washing machine, wooden almira, bed, dressing table, dianing table, tea table, entire house hold utensils including brass utensils, gold ear ring, gold nose ring, gold mangtika, gold chain for my husband, gold ring for my husband, gold ring for my father in-law, silver coins to every family members and relatives who attended the wedding, silver payal, silver key ring and cash Rs. 11,000/- given to groom during the time of marriage and Cash dowry 15,00,000/-.
- That after I went to my in-laws house after my marriage I had a very horrifying welcome by the taunts of my mother in law namely Santoshi Balmiki and Poppy Balmiki and also by my Sister in-law namely Anu Balmiki saying that “mera sona jaise beta ko dahej mai kuch v nhi mila

na he ladi acchi mili na he koi Car ya AC mila” with such statement I was welcomed in my in-laws house.

5. That the very next day in my in-laws house my both the mother in-law came outside my room and started knocking and banging the door loudly calling out my name at around 4:00 AM in the morning and said that “avi tak uthi nhi hai Kumbhkarna” so much work are there in the house who will do, hearing this I came out of my room hurriedly and the torture upon me by them increased rapidly day by day and every now and then they use to taunt me for the dowry and the things my mother did not give in my wedding.
6. That I did not think right to tell my mother or complain about the incident to the police station just to save the reputation of both the family and to save my married life.
7. That both my mother in-law use to torture me both physically and mentally and whenever my sister in-law use to come to the house she use to instigate my husband as well as my mothers in-law and then they use to start fighting with me and assault me with fist and blows, that on 22/05/2024 at around 11:30 PM my sister in law had come along with my both mother in-law and forcefully entered in my room and started assaulting me by catching hold of my hair log and dragging me from my room and assaulted me mercilessly and drove me out of the house. Thereafter I went to Siliguri District Hospital and got treated my self. After that incident my husband came and said me not to take any legal actin as he will try to get thing better in the house and I went with him in my in-laws house but not went better since then and everything remained same.
8. That today i.e. 31/07/2024 at around 11 to 11:30 AM again my both the mother in-law namely Santoshi Balmiki and Poppy Balmiki, including my sister in law namely Anu Balmiki, Uncle namely Rajesh Balmiki and

Ajay Balmiki (brother in-law) including my husband made a conspiracy to kill me by leaving the gas open so that I can get burnet alive but when this plan of their failed all of them caught hold of me tightly and tried to strangulated my neck by my dupatta which I was wearing with the intention to kill me but I tried to free myself from their clutched but failed to do so and decided to shout for help and listening to my hue and cry the para people came and saved me from there clutches and then I called my mother and went to siliguri district hospital and got treated myself and received first aid also.

9. That all the above mentioned people namely 1. Sanjay Balmiki , 2. Santoshi Balmiki, 3. Poppy Balmiki, 4. Anu Balmiki, 5. Rajesh Balmiki, 6. Ajay Balmiki from the very beginning of my married life have been torturing me both physically and mentally and they have been planning and plotting since long to kill me and today they all left the gas open to burn me alive and had left me home alone and when I came to know about their intention and plan they tried to kill me by strangulating my neck with my dupatta and also tear my cloths so that I cannot go out of the house for help out of shame.

I therefore request you to kindly take necessary legal action against all the above culprit for the ends of justice.
