In producing herewith one arrested accused person named Mani Kumar Chhetri @ Basant (42) s/o Man Bahadur Chhetri of Farabari, Nepali Basty, P.O Sahudangi Hat, Dist. Jalpaiguri along with following articles under proper seizure list.

Thirty Seven (37) Bottle pieces of KINGFISHER IMPERIAL STRONG BEER each bottle containing 650 ml having MRP- Rs 135/- [Total 37X650 Litre = 24.05 Litres] marked as "Exhibit-A"

 Twenty Six (26) Bottle pieces of TUBORG PREMIUM BEER STRONG each bottle containing 650 ml having MRP- Rs 135/-, Batch No. 102 [Total 26X650 Litre = 16.90 Litres] marked as "Exhibit-B".

I, SI Sailesh Subba of Bhorer Alo P.S, SPC would like to lodge this written complaint against the above noted arrested accused namely Mani Kumar Chhetri @ Basant (42) s/o Man Bahadur Chhetri of Farabari, Nepali Basty. P.O Sahudangi Hat, Dist. Jalpaiguri to the effect that today on 28.07.2024 at about 21.05 Hours while performing mobile van duty at Ambari Out Post area I, received a specific source information that one Mani Kumar Chhetri of Farabari Nepali Basty has stored huge quantity of illicit liquor at his house for the purpose of selling the same illegally. Accordingly, I informed the fact to the officer-In-Charge, Ambari Out Post and as per his kind order and direction myself along with force left for Farabari Nepali Basty to work out the source information in hand. On the way I also informed the special van officer ASI Rana Yadav to accompany with us for holding joined raid.

At about 21.45 hours I along force and Special van arrived at Farabari and searched for the witness namely (i) Sanjib Roy s/o Goutam Roy of Jalpai More, PO+PS Siliguri, Dist. Darjeeling and (ii) Bittu Saha S/o Bikash Saha of Sukantanagar, P.O Rabindra Sarani, P.S Bhaktinagar, Dist. Jalpaiguri and shared them information in hand and asked them to accompany with us during raid and accordingly they agreed for the same. At about 21.50 hours being identified and shown by my source I along with the accompanied force held raid at one of the house in presence of witnesses and managed to apprehend one male person and started interrogation. During interrogation he disclosed his identity as Mani Kumar Chhetri @ Basant as noted above and stated that he has stored some quantity of illicit liquor at his house for selling the same to his local customer. On being asked to produce the stored liquor the apprehended person produced and recovered above noted seized liquor from his house. On demand he failed to produce any valid license/papers for selling and storing illicit liquor.

On further interrogation he stated that he has been involved in selling and possessing of illicit liquor without any valid license since few months for his illegal gain. Accordingly, I seized the above-noted liquor under proper seizure list and labeled the seized articles and arrested the above noted person named Mani Kumar Chhetri Basant (42) s/o Man Bahadur Chhetri of Farabari, Nepali Basty, P.O Sahudangi Hat, Dist. Jalpaiguri after observing all sorts of formalities at the spot for violating the norms of Bengal Excise Act. The reason of arrest was apprised to the accused person verbally. The whole process of search and seizure was made in between 21.50 Hours to 22.10 Hours.

I, therefore, pray before your good self that a specific case under proper section of law may kindly be initiated against the arrested accused namely Mani Kumar Chhetri @ Basant (42) s/o Man Bahadur Chhetri of Farabari, Nepali Basty, P.O Sahudangi Hat, Dist. Jalpaiguri and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
