Sub: Lodging of F.I.R. against **SRI ADI SAHA**, Son of Sri Ananda Saha, resident of Nigampally, Atul Prasad Sarani, Siliguri and also available at C/O shop of Sri Ananda Saha, near khelaghor More (beside Axis Bank ATM Counter), Hakimpara, Siliguri.

Sir,

1. the undersigned, inform you as follows:

1. That on 07.07.2024 between 6:00 p.m. to 6:30 p.m., after observing the Rath Yatra Programme while I along with my mother namely Smt. Jaya Banerjee, wife of Sri Prolay Banerjee, was coming back home walking, without any fault on the part of my mother a scooter bearing Registration No. WB 74 AT 1756 plied by abovenamed Sri Adi Saha hit my mother from behind at excessive speed near Rabindra Sangha Club, Siliguri and as a consequence thereof my mother fell down on the ground and sustained grievous injury and became unconscious.
2. That subsequently with the help of few pedestrians I boarded a Toto and brought my mother to Basu's Clinic, Collegepara, Siliguri and after initial treatment in emergency section the attending Doctors of said clinic referred my mother to Neuro Specialist Hospital on account of her very serious condition.
3. That thereafter I brought my mother to Anandalok Hospital, Sevoke Road, Siliguri and she was admitted thereon at ICU on the same day i.e., 07.07.2024 in unconscious state and under ventilation due to brain hemorrhage sustained by her owing to such fatal hit by abovenamed Sri Adi Saha.
4. That the aforesaid fact was duly reported to you on 16/07/2024 in writing.

5. That in continuation of my aforesaid complaint dated 16.07.24, I intimate you that my mother while undergoing continuous treatment since 07.07.2024 in Anandalok Hospital, Sevoke Road, Siliguri, unfortunately expired on 30.07.2024 in the said Hospital.
6. That my mother died due to the injury sustained by her on 07.07.2024 owing to the rash and negligent driving of abovenamed Adi Saha.
7. That as I had too observed religious rites and rituals the fact of death of my mother is therefore reported to you after delay of three days.

In the above circumstances, you are kindly requested to take appropriate legal action against abovenamed Sri Adi Saha according to law and ensure proper justice to us.
