Sir,

In producing herewith three (03) accused person namely S/O Bal Singha, 2. Gopal Barman (20) S/O Lt. Kailash Barman and 3. Bijay Barman s/o Shambhu Nath Barman all of Bhenchijote, Patharghata, PS- Matigara, District- Darjeeling along with following seized articles as per proper seizure list:-

1. One Blue coloured Honda Activa Scooty without number plate having Engine No. JF49E 84038781 & Chasis No. ME4JF49DIIJ8008809.

I, ASI Kalachand Singha of Khalpara TOP under Siliguri Police Station beg to report that today on 02.08.2024 at 15.05 hrs. received a specific source information that three (03) persons are coming at Dangipara in front of Swastika Club with a stolen Blue coloured Honda Activa Scooty without number plate for selling the same to their designed customers for their wrongful gain. The matter has been diarized vide Khalpara TOP GDE No.44 Dt- 02.08.2024. Accordingly I informed the matter to Officer-in-Charge, Khalpara TOP under Siliguri Police Station and expressed the entire information. Accordingly, he directed to me to work out the information immediately. Hence at about 15.15 hrs. as per his kind direction myself along with SI Newton Biswas, ASI Injamamul Hoque, C/ 390 Sujit Paul, CV/980 Ranjan Ojha and CV/916- Amresh Sah all of Khalpara TOP under Siliguri Police Station, Siliguri Police Commissionerate left for Dangipara in front of Swastika Club to verify the veracity of the information which refers to Khalpara GDE No. 45 Dt. 02.08.2024 by Govt. Vehicle .

Then as per source information we approached towards Dangipara in front of Swastika Club under Siliguri Police Station. At 15.35 hrs. we reached at Dangipara in front of Swastika Club & as per identification by the source I managed to apprehend three (03) persons who were coming at Dangipara in front of Swastika Club with a stolen Blue coloured Honda Activa Scooty without number plate . On being asked they disclosed their identity as noted above and admitted that they had stolen the scooty from Matigara area and came at Dangipara to sell the same to their designed customer . On being asked they failed to produce any documents in r/o said stolen Scooty. Accordingly, I seized the stolen Blue coloured Honda Activa Scooty without number plate having Engine No. JF49E 84038781 & Chasis No. ME4JF49DIIJ8008809. The seizure was made between 15.30 hrs. to 15.45 hrs. in presence of available witnesses and the process of search & seizure was video graphed after obtaining all formalities. On further asked the apprehended persons confessed that they are involved in stealing and selling of stolen scooty /motor cycles since long. Then I arrested the above noted accused person after observing all guidelines of Apex court.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely 1. Krishna Singha (25) S/O Bal Singha, 2. Gopal Barman (20) S/O Lt. Kailash Barman and 3. Bijay Barman s/o Shambhu Nath, Barman all of Bhenchijote, Patharghata, PS- Matigara, District- Darjeeling.
