SUB: INTIMATION OF THREAT AND ASSAULT

'Sir,

I, Sri Sanjay Datta, S/o Late Kartick Datta, resident at Mahananda Para, Siliguri, D. L Roy Sarani, Ward No. 06 of SMC, P.O & P.S: Siliguri, District: Darjeeling, Pin Code: 734001 would like to bring to your attention that I am a lawful tenant under Sri. Saibal Chakraborty, S/o Late Panchugopal Chakraborty, resident of 24, D. L Roy Sarani, Mahananda Para, Siliguri, Ward No. 06 of SMC, P.O & P.S Siliguri, Dist: Darjeeling, Pin Code: 734001 for the non-residential tenanted premises being godown measuring more or less 620 sq ft at the ground floor of a two storied building constructed in and over land recorded in RS Khatian No. 2343, RS Plot No: 8375 within Mouza Siliguri, Mahananda Para, Ward No. VI of Siliguri Municipal Corporation, P.S Siliguri, Dist: Darjeeling.

Over the past few years, my landlord Sri. Saibal Chakraborty has been harassing me and trying to oust me from the tenanted premises I have been lawfully occupying under an agreement. Lastly, on 09/07/2024 he sent me a legal notice to vacate the said premises. I have through my lawyer duly responded to the notice.

Today i.e on 31st July 2024 at around 2:30PM, while I was returning home with my minor daughter, Sri Saibal Chakraborty saw me in front of Bata Showroom (Bata Gali), Hill Cart Road, Ward No. 6, P.S: Siliguri, Dist: Darjeeling, and very disrespectfully called me over and started abusing me, demanding to know why I was not answering his son's calls on my mobile phone. I explained that I was unaware his son had called, but he responded with filthy language and threatened that no lawyer would be able to save me. He demanded that I vacate the tenanted premises within two days or I would face dire consequences. He also threatened to throw away all the goods from the godown if I did not comply.

I was abused and threatened and somehow managed to escape from Sri Saibal Chakraborty's clutches. I have been a lawful tenant since 1995, dutifully paying all my rent on time. I fear Saibal Chakraborty may harm me and cause further damage to my goods and property.
