Sir,

With due respect and in producing herewith one (01) accused person Manglu Munda (23 yrs) S/O Ganesh Munda of Simulguri, Dakshin Palash, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling under arrest and one truck having registration number WB/76/0695 Loaded with illegal River bed materials under proper seizure list. I, ASI Biplab Kr Das of Pradhan Nagar P.S, SPC do hereby lodge this Complaint against the the above noted accused person namely Manglu Munda (23 yrs) S/O Ganesh Munda of Simulguri, Dakshin Palash, PO- Champasari, PS- Pradhan Nagar, Dist. Darjeeling to the effect that on 01.08.24 at 22.45 hrs I received an information that one road traffic accident took place at Samar Nagar Battala under PS- Pradhan Nagar, Dist.- Darjeeling. Accordingly, I informed the fact to the I/C, Pradhan Nagar PS and as per his kind order and direction myself along with RT van officer ASI Sanjib Mukharjee and force left for Samar Nagar Battala under PS Pradhan nagar, Dist.- Darjeeling by govt vehicle. After arrival at the spot, I found local people detained one truck having registration number WB/76/0695 loaded with river bed materials and also detained the driver of the said vehicle. I took into custody of the said driver. On enquiry it could be revealed that the said truck badly dashed one ox at Samar Nagar Battala under PS- Pradhan Nagar, Dist. Darjeeling causing the said ox sustained injury and local people shifted the injured ox to the hospital. During local enquiry it could be revealed that the accident occurred due to rash and negligent driving of the driver of vehicle number WB/76/0695. On interrogation the accused driver disclosed his identity as noted above and also admitted his guilt. On demand he failed to produce any documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation he disclosed that he loaded such illegal river bed materials from Mahanda river near South Palash by illegal means with a view to sell the same for his illegal gain. Accordingly, I seized the above noted vehicle having registration number WB/76/0695 loaded with illegally mining river bed materials under proper seizure list and subsequently arrested the driver of the said vehicle after maintaining all formalities of arrest and brought to Pradhan Nagar PS. The search and seizure was made on 01.08.24 in between 23.45 hrs to 23.55 hrs under the coverage of vediography.

Under the above noted fact and circumstances, I therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Manglu Munda (23 yrs) S/O Ganesh Munda of Simulguri, Dakshin Palash, PO- Champasari, PS-Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
