Sir,

In producing herewith one (01) arrest person namely Raja Saiba (23), S/O Shyamlal Saiba of Majua Busty, PS. Bhakti Nagar, Dist. Jalpaiguri along with (01) one tractor having registration number WB/73/G/3720 with tolly containing illegal River bed materials under proper seizure list.

I, SI Bandhan Roy of Pradhan Nagar P.S., SPC do hereby lodge this complaint against the above noted accused person namely Raja Saiba (23), S/O Shyamlal Saiba of Majua Busty, PS. Bhakti Nagar, Dist. Jalpaiguri to the effect that on 02.08.2024 at 21.45 hrs as of my special mobile RT van duty vide Pradhan Nagar PS GDE No. 106 Dated 02.08.2024, I detained one person at Champasari Anchal, in front of Sri Guru School under Pradhan nagar P.S. with one tractor having registration number WB/73/G/3720 loaded with illegal River bed materials which is coming from South Palash, Mahananda river Bed, under PS.- Pradhan Nagar, Dist.- Darjeeling and proceeding towards Champasari More. On being asked he disclosed his name and identity as noted above and he driving of the vehicle. On demand he failed to produce any valid documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation he disclosed that he loaded such river bed materials from Mahananda River Bed near South Palash by illegal means with a view to sell the same for his illegal gain.


Accordingly, I seized the above noted vehicle having registration number WB/73/G/3720 with a tolley containing loaded illegal river bed materials under proper seizure list and subsequently arrested him after maintaining all formalities of arrest and brought to Pradhan Nagar PS. The search and seizure was made on 02.08.2024 in between 21.50 to 22.03 hrs under the coverage of videography as per norms of BNSS.

Under the above noted fact and circumstances, I therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Raja Saiba (23), S/O Shyamlal Saiba of Majua Busty, PS. Bhakti Nagar, Dist. Jalpaiguri and arrange for its investigation.


