With due respect, I, TATUN GUHA, Son of Late Manindra Kumar Guha, Resident of Namita Nilay, College Para, Siliguri, P.O. & P.S. Siliguri, Dist.. Darjeeling, would like to lodge this written complaint before your good authority to the effect that I am a business person and I have been running and carrying a business under the name and style as "Rahul Guha Steel Industries" on and from Kadamtala, Pokaijote, Near Ice Factory, Ward No. 46 of S.M.C., Siliguri, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling. Sir, in course of my said business, since last six months ago, I have engaged one person namely Umesh Chettri, permanently resident of Birpara and presently residing at Behind Sree Guru Vidyamandir, Near Boy's Hostel, Ward No. 46 of S.M.C., Siliguri, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, as my driver.

On 30/07/2024 at about 09.30 P.M., when my Manager namely Samar Sheikh was alone in our factory, said Umesh Chettri criminally trespassed into our said factory without taking any permission either from me or from my said Manager and confined himself in the factory and at that time, when my Manager went to the bathroom, said Umesh Chettri taking advantage of his absence, entered into the office room and took a sum of Rs. 35,000/- only from the locker and when my Manager came out from the bathroom, said Umesh Chettri again confined himself in the third floor of the building but could not escape there from and when my Manager noticed some activities, in the third floor, he trying to trace out the same and seeing the said situation, said Umesh Chettri tried to escape there from by applying criminal force to my said Manager and when my Manager started to shout and tried to call me and hearing such noise, I came at the spot and caught said Umesh Chettri red handed and at that moment, said Umesh Chettri took a bamboo stick on his hand and tried to assault me and my Manager with the said bamboo stick with an intention to kill us and somehow, managed to flee away from the spot with an amount of Rs. 35,000/- only and while fleeing away there from, he fallen down and injured himself, he managed to flee away from the spot. I, therefore, request you to kindly investigate into the matter properly after treating my complaint as an FIR and please take appropriate strong legal action against said Umesh Chettri as per the provision of law and oblige thereby.
